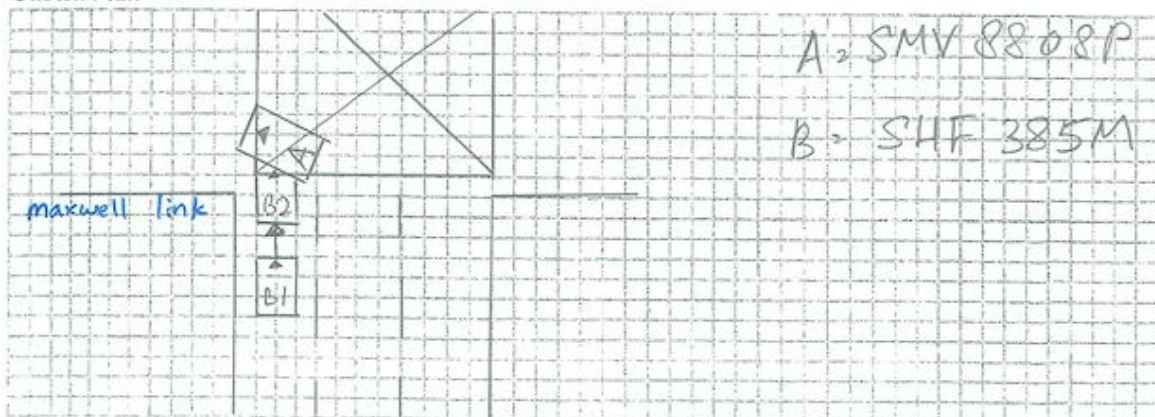

Describe Circumstances of the Accident

On 08.11.2022 at about 2030hrs. I was travelling along Maxwell link. Suddenly the taxi (vehicle B = SHF 385M) was stationary at the double yellow zig-zag line and his hazard light was on as shown in the video. I overtook him from the right. I was unable to turn left on the left lane as vehicle was occupying the lane with hazard light when I almost completing my turn, vehicle B moved off from stationary position and hit my vehicle (SMV 8808P)
