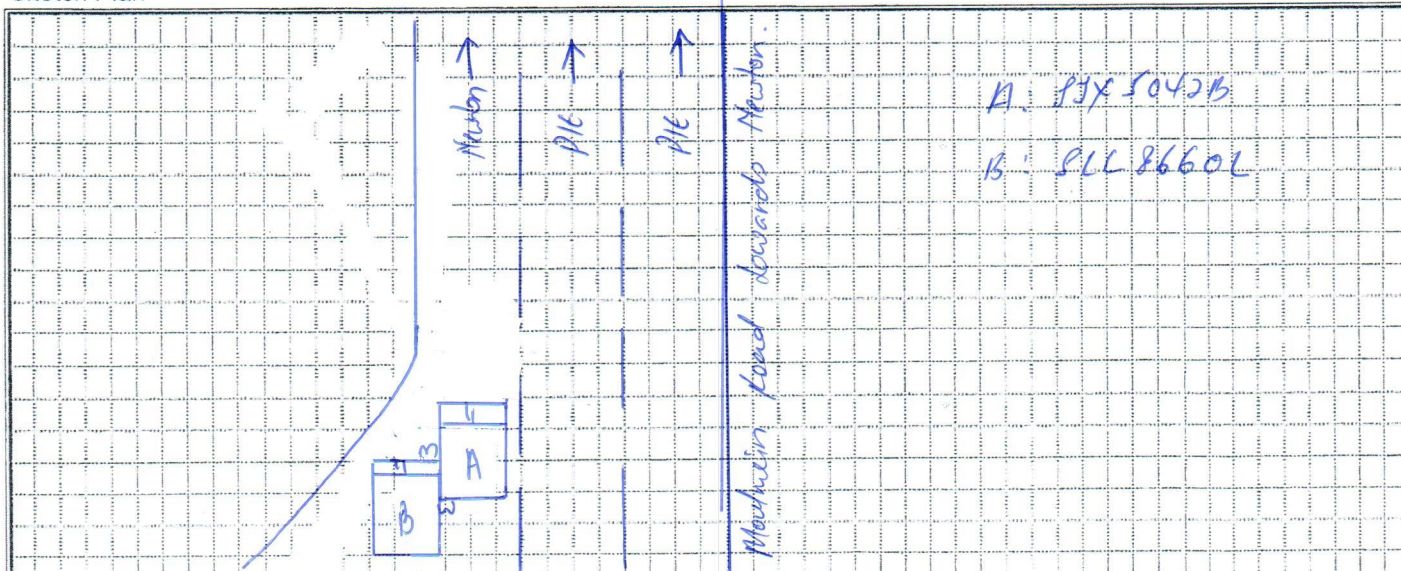

THIS AGREEMENT MADE ON this 4th day of October 2022 between -

1. **CLX55 PTE LTD** (UEN No. 201807868G) a company incorporated in Singapore and having its registered office at 22 Sin Ming Lane #06-76 Midview City SINGAPORE 573969 (hereinafter referred to as "**the Owner**");
2. **TAN KOK SAN, (NRIC S7250254Z) of Blk 411 Commonwealth Ave West #06-3073 Singapore 120411**  
(herein after referred to as "**the customer**").  
(collectively, referred to as "**the parties**")

IT IS HEREBY AGREED as between the Parties as follows -

### 1. AGREEMENT FOR HIRE

- 1.1. The Owner will let and the Customer will take on hire upon the following terms and conditions the Car.
- 1.2. This Agreement is a conditional agreement and will commence upon the receipt of delivery of the Car except for the Deposit, part of which would be payable upon the signing of this Agreement.

- 1.4. The Customer shall be a mere bailee of the Car and no interest shall pass to the Customer.

### 2. HIRERATE
