On 30/10/2022 at about 1750hrs, I was travelling along Jurong Town Hall Road in my vehicle (YQ2439U), I was heading back home located at 49 Jurong East Ave 1 #09-06 Parc Oasis S(609781). After a while I slowed down my vehicle as it was a red light at the junction, however before my vehicle could completely stop, my vehicle had gently knocked the rear bumper of the vehicle in front of my vehicle (SLZ2985R). The driver (A2) then stepped out of his vehicle (V2) and immediately checked the rear bumper of his vehicle, to which I also stepped out of my vehicle and checked the front side.

I discovered no damages to my vehicle and A2 discovered only one small scratch to his vehicle's rear bumper, A2 and I exchanged details, but I do not have the contact number of A2. After exchanging the details, we both left the scene.

On 08/11/2022 at about 0921hrs, I received a letter from my company regarding the accident that happened on 30/11/2022, the letter states that my company (Swee heng Landscape & Construction Pte Ltd) is aware of what happened but still did not require me to make a police report, but then on 24/11/2022 at about 1300hrs I received a message from my boss's wife informing me that the insurance company had requested for a police report of the accident, hence I am only lodging this report today on 24/11/2022
