Brief details.

On 31st October 2022 at around 1300hours, I was from work riding back home. I was riding at Tampines Expressway exiting the filter lane towards Sengkang. As I slowed down at the filter lane on the left, a lorry GBH 4854K infront at the right lane suddenly swerve into my lane cornering me to a tight spot. Due to that reckless driving and negligence of sudden change in lane, I quickly brake and bail to avoid any collision and thus fell off my bike and got into accident. That sudden impact to the kerb got me into a short few seconds of concussion which I'm only aware when the driver came out from the lorry to ask me
