

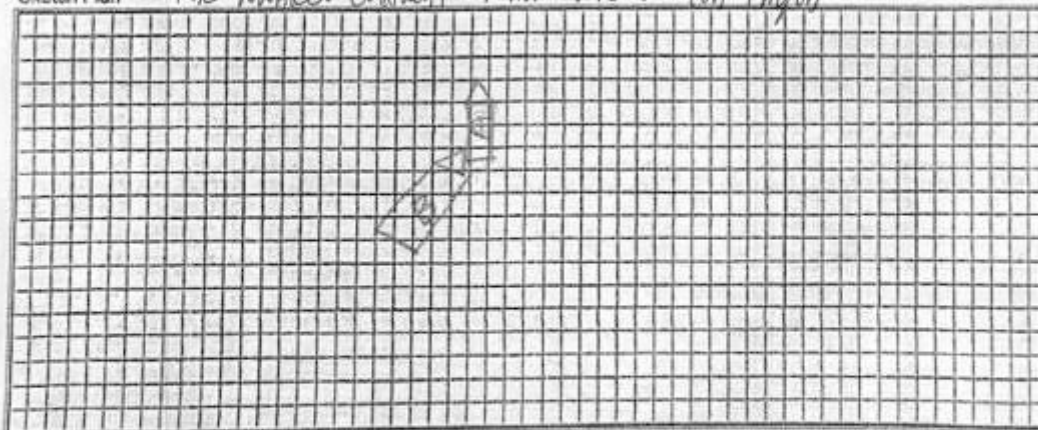

I was riding on my motorcycle, FBP1755R, on PIE towards Changi when I was sideswiped by a white car, vehicle number SCH1018X, after Lor 2 Toa Payoh expressway entrance.

I was riding at a constant speed of 80km/h on the second lane from the right. Throughout my journey, I had not seen the white car in my view and after being hit, I was unaware of who I was hit by.

After the collision, I sat up by myself and the driver of the white care approached me asking if I was okay. I asked him if he was the one who hit me to which he answered 'yes it was me'.

A couple (1 male and 1 female) witnessed the accident and helped me call for an ambulance. They have in-car camera footage of the accident.
