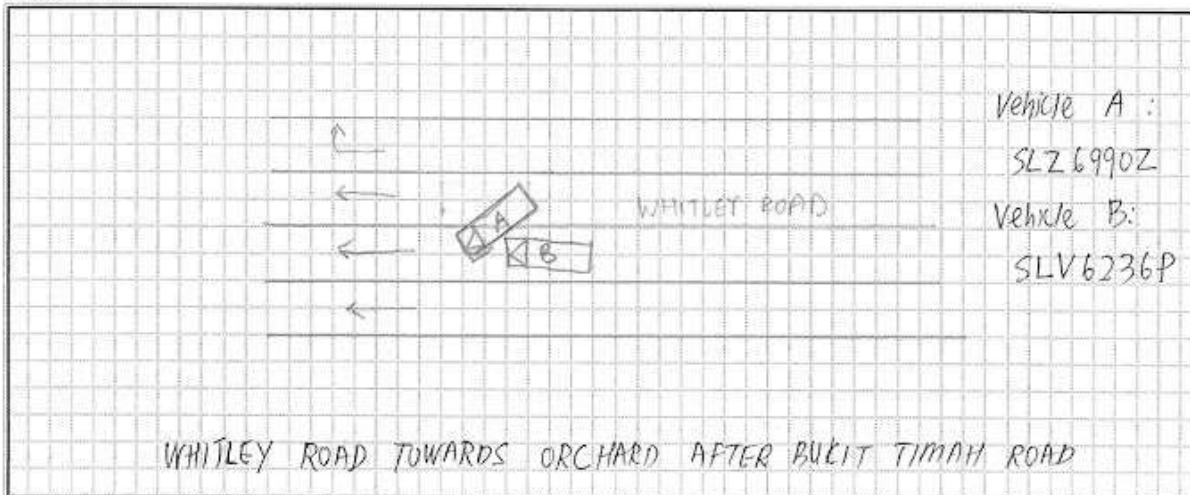

Describe Circumstance of the Accident

On 4 Nov 2022 (Friday) at about 6:30pm, I was driving my vehicle (SLV 6990Z) along ~~Sekela~~ <sup>Whitley</sup> Road when I got into an accident with another vehicle, SLV 6236P. (just off bukit timah road, toward orchard road)

I was making a lane change to the ~~left~~ <sup>middle</sup> lane and had my signal on for about 15s before proceeding to make the lane change when there was a break in the traffic flow. However, as I was changing lanes, a car (SLV 6236P) appeared at my side and ~~the~~ both cars made contact. My left side doors were both scratched while the other car's front right bumper and front light were damaged. Although I drove in the lane of the other car, ~~the~~ <sup>my</sup> sense is that the other car had increased his speed, ~~the~~ hence while the car was not in my line of sight as I made the lane change, it appeared in my blind spot as I was completing the lane change.
