

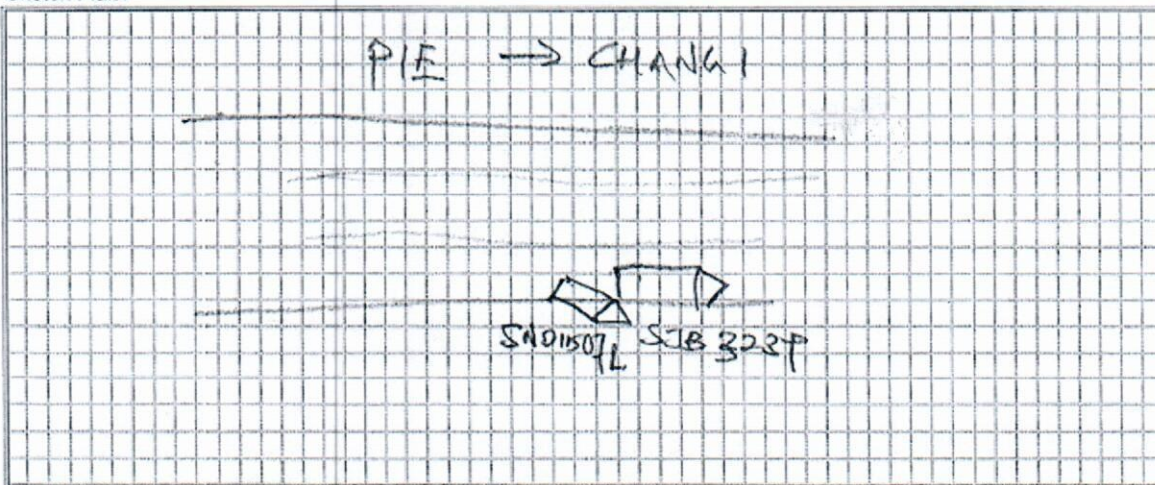

There was a passenger with me.


I got out of my car to check the damage and the mother of the driver admit is their mistake because they did not manage to stop in time.
