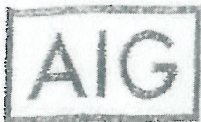

**SKETCH PLAN**

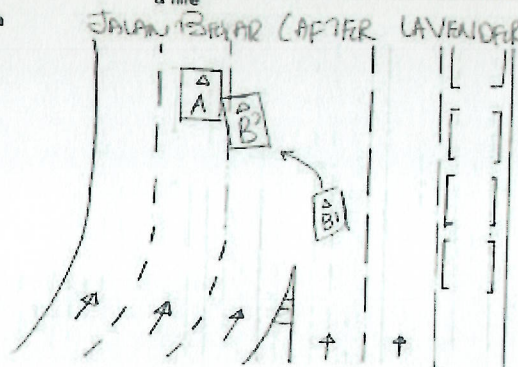
