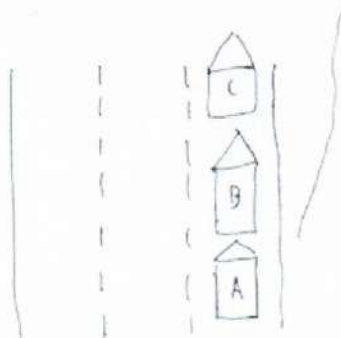

C- SLH 8842A




Describe Circumstances of the Accident



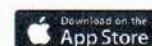
