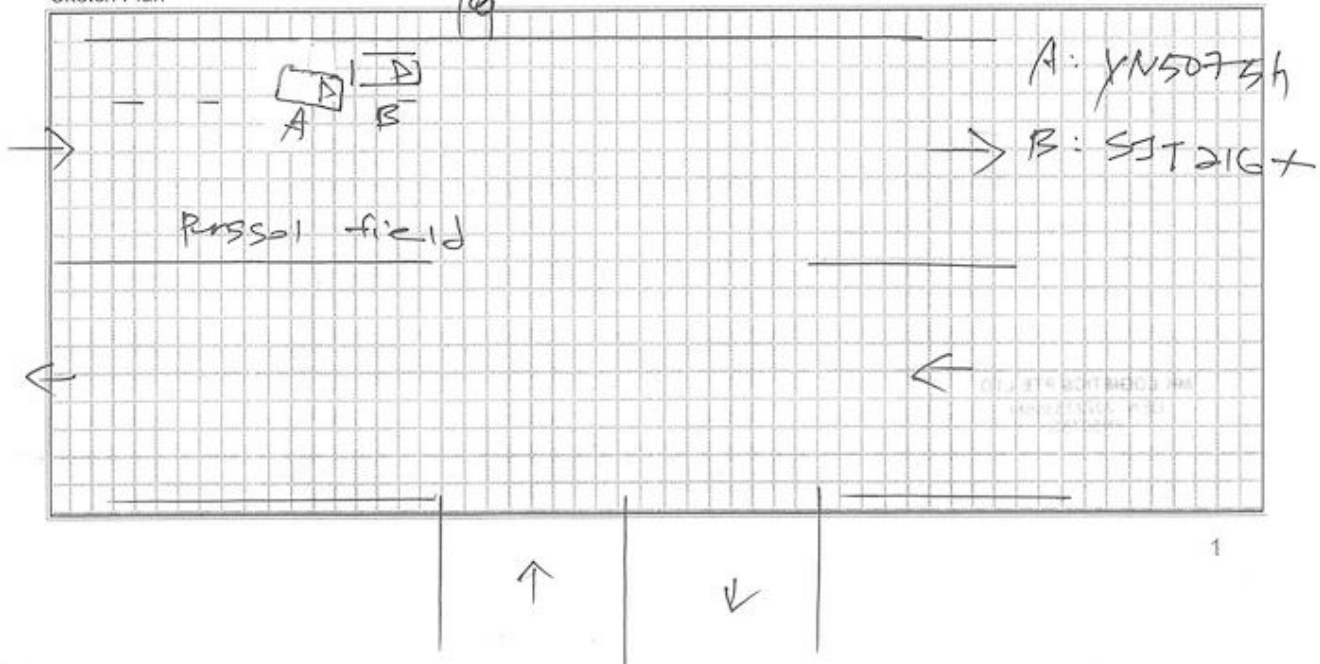

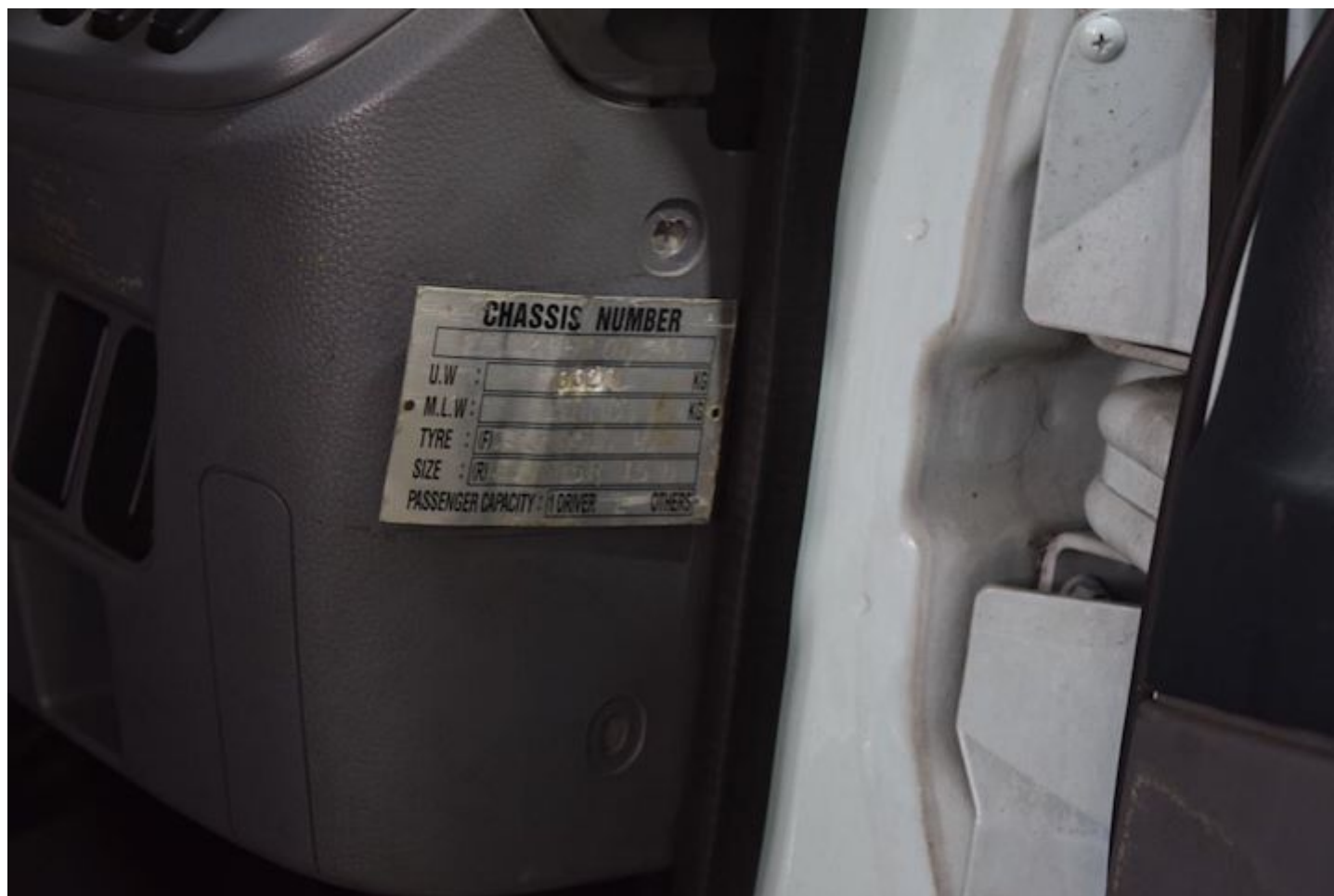

CONTINUATION OF REPORT**Brief Details.**

On 09/11/2022 at around 10.30pm, I was travelling along Punggol Field in my vehicle (YN5075G) along with my assistant. I was travelling at about 30km/h. As I was approaching the junction of Punggol Field and Punggol Place, I observed that the traffic light was still green and thus maintained my speed. Afterwhich, the vehicle in front of me (SJT216X) suddenly braked before the junction. I activated my brakes while turning my vehicle to the lane on my right to try to avoid the vehicle. My vehicle hit the other vehicle. I parked my vehicle along Punggol Place in order not to block the oncoming traffic.

Afterwhich, I proceeded to check on the other party. He refused to move his vehicle. Thus, I moved my vehicle back to Punggol Field. Afterwhich, I checked the damages on my vehicle and observed multiple dents on the front of my vehicle and the front bumper has been dislodged. I observed the damages on the other vehicle was the rear of the vehicle was seriously damaged. I checked with the other party and he informed me that he is not injured. However, he refused to exchange particulars and wanted to call police. Traffic police resource arrived on scene and interviewed myself and the other driver.
