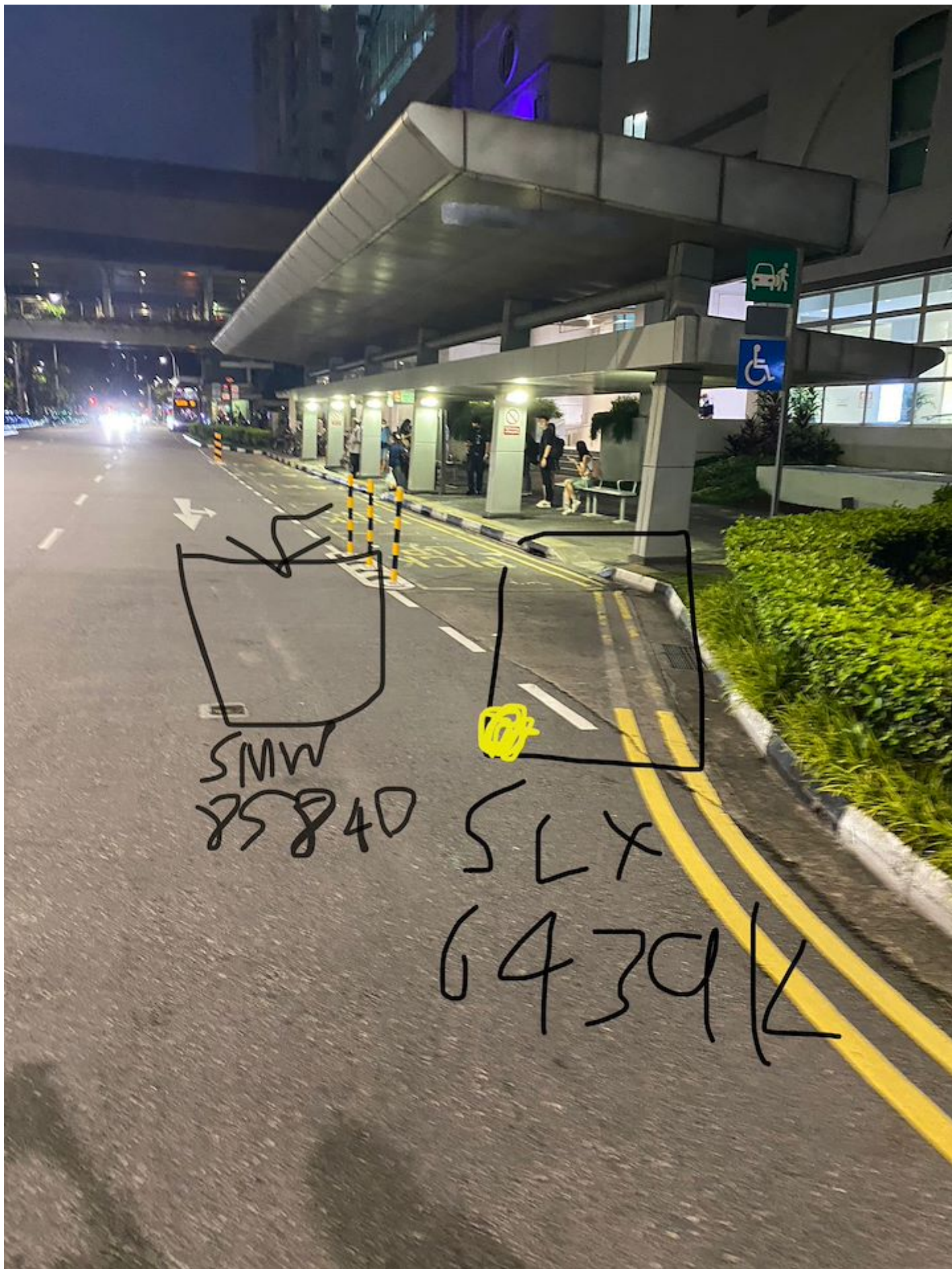




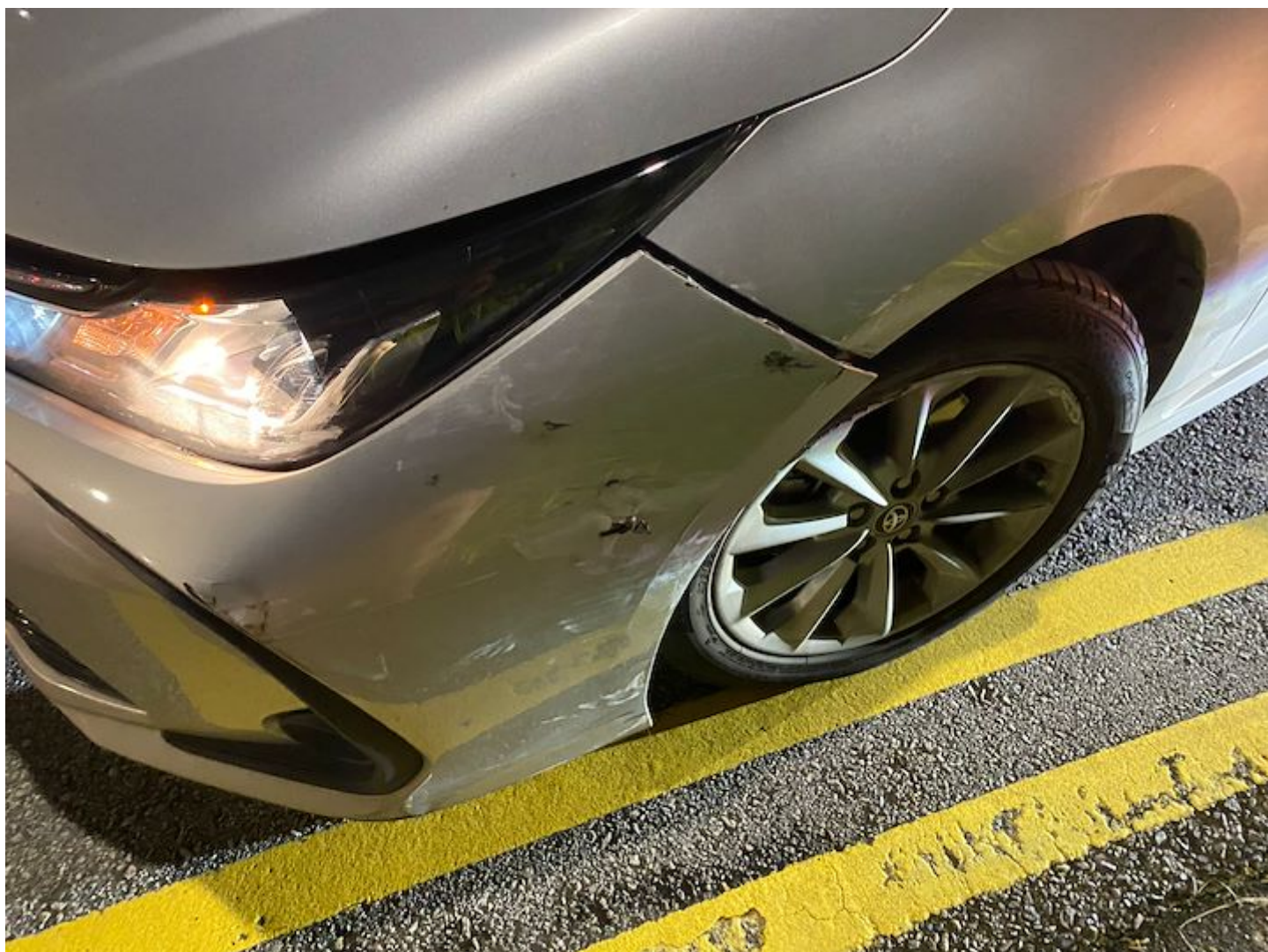

## Brief Details.

I was exiting the pick up with a give way line, with my right signal turned on. I checked my blindspot, and cleared right and proceeded out as traffic was clear. As I was turning out, the right side of my car bonnet had already passed the give way line, traffic was still clear. The other vehicle involved (SMW8584D) was part of the queue in the pick up point, did not wait for the front vehicle to move, and decided to cut out to traffic from where he was, while I was already exiting the pick up point, past the give-way line with my right signal on. My passengers noticed the car (SMW8584D) made the abrupt exit and sped up, alerting me to stop. I stopped in time, whereas the other driver did not stop and his left bumper hit my car. No casualties or injuries.
