Brief Details.

On 05/11/2022 @ 0825hrs, I was lining up behind one Black Toyota Saloon Car, SJE1436A at the junction of Pasir Ris Dr 12 and Pasir Ris St 72 towards the back of Pasir Ris West Plaza. When the right turn arrow turned green, I rode off behind the Black Toyota Sedan. A Blue Nissan SUV, SMA8486U was driving on the opposite direction lane beat the red light and crashed into the Black Toyota Saloon Car that was in front of me. The Blue Car then spun and hit my motorbike and knocked me over, injuring me. Traffic Police as well as SCDF Came to scene. I was then conveyed to the Hospital. I suffered a deep wound on my left leg. I received a 31day MC and was also warded from 5/11/2022 to 13/11/2022.
