ON A FAIR DAY ON 16/11/2022 AT APPROXIMATELY 10.09AM, I WAS TRAVELLING ALONG GEYLANG ROAD, HEADING TOWARDSS THE DIRECTION OF BUGIS. WHEN I WAS ABOUT TO TURN TOWARDS LORONG 1 GEYLANG AT THE JUNCTION BETWEEN GEYLANG ROAD AND LORONG 1 GEYLANG, WHILE MAKING THE RIGHT TURN, (SNC1999E) AUDI, WHO WAS ON MY LEFT ALSO MADE A RIGHT TURN IN THE SAME DIRECTION AND ATE INTO MY LANE WHILE BOTH OF OUR CARS WERE TURNING RIGHT AND THUS CREATED THE ACCIDENT BY HITTING ON THE LEFT FRONT (PASSENGER SIDE) BUMPER AND FENDER OF MY CAR (SGD2566S).

On a fair day on 16 Nov 2022 @ approximately 10:09am, I was travelling along Gaylang Road heading towards the direction of Bays. When I was about to turn towards Lot 1 Gaylang at the junction between Gaylang Road & Lot 1 Gaylang, while making the right turn, SNC 1949E Audi, who was on my left also made a right turn in the same direction and cut into my lane while both of our cars were turning right and thus created the accident by hitting on the left front (passenger side) bumper and fender of my car SGD 55665.
