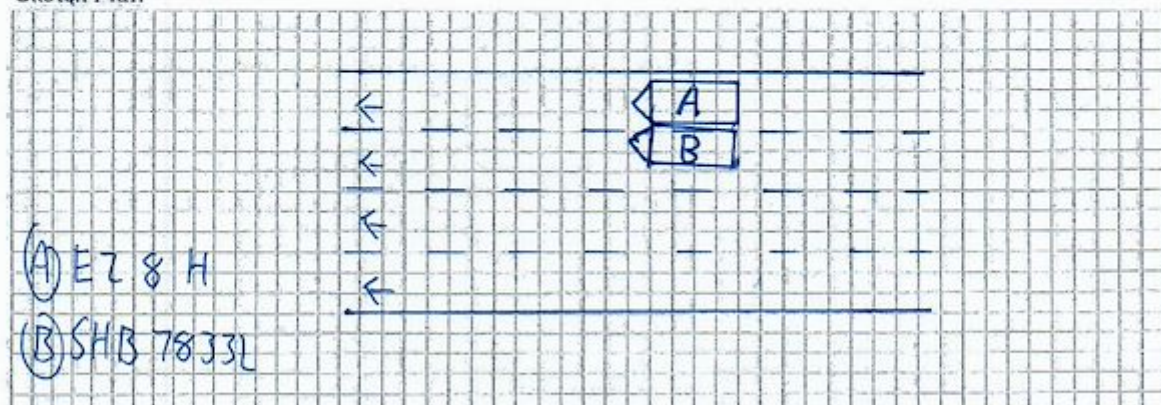

Brief Details.

The driver appeared to have no visible injuries. However, he informed that he felt neck pain. He also informed that his passenger was also injured. He informed that ambulance and Police were informed. He said that since there were no damages on both vehicles, he suggested me to pay for their medical expenses. I requested to see the passenger, however, he told me not to open the taxi door. Hence, I was not allowed to see the passenger. Subsequently, he informed that his passenger did not call for ambulance and Police and suggest to me again to pay for their expenses. As such, I informed him to lodge a Police report instead and informed him that my insurance would settle the matter. Since the Police
