#### CIRCUMSTANCES OF ACCIDENT

ON 18/11/2022 AT AROUND 5.45PM, WHEN DRIVING INTO THE CARPARK OF CITADINES BALESTIER, THERE ARE 2 CARS (SME7269R & SKS9577M) ILLEGAL STOPPING AND BLOCKING THE ROAD TO THE CARPARK. SO AFTER HONKING THEM TO GIVE WAY, BOTH DRIVERS STARTED TO DRIVE OFF. IN ORDER TO GIVE WAY FOR HIM, AFTER CHECKING REAR MIRROR TO MAKE SURE NO CAR IS BEHIND, I STARTED TO REVERSE AND STOP TO GIVE WAY TO THE CAR. BUT UNKNOWNLY, SKS9577M MADE AN ILLEGALLY TURN AGAINST A ONE WAY ROAD AND DRIVE BEHIND MY REAR OF THE DROP OFF OINT. END UP, CAUSE THE ACCIDENT. SKS9577M COULDN'T MAKE A TURN FROM THE STOP LINE. HE HAD TO DRIVE OUT TOWARDS THE EXIT.

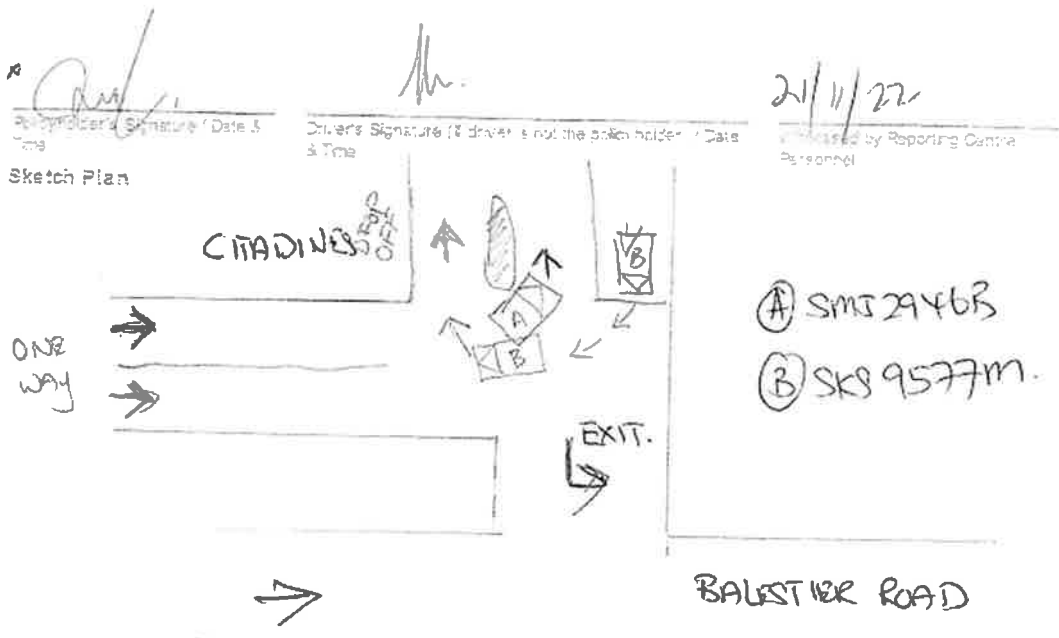

Describe Circumstances of the Accident:

ON 8/11/2022 AT AROUND 5:45 PM, WHEN DRIVING INTO THE CARPARK OF CITADINES BALESTIER. THERE ARE 2 CARS (SME 726R ~~AND~~ SKS 957AM) ILLEGAL STOPPING AND BLOCKING THE ROAD TO THE CARPARK. SO AFTER HONKING THEM TO GIVE WAY. BOTH DRIVERS STARTED TO DRIVE OFF. IN ORDER TO GIVE WAY FOR HIM. AFTER CHECKING REAR MIRROR TO MAKE SURE NO CAR IS BEHIND. I STARTED TO REVERSE AND STOP TO GIVE TO THE CAR. BUT UNKNOWINGLY SKS 957AM MADE A ILLEGAL TURN AGAINST A ONE WAY ROAD AND DROVE BEHIND MY REAR OF THE DROP OFF POINT END UP CAUSES THE ACCIDENT (THE SKS 957AM COULD NOT MAKE A TURN FROM THE STOP LINE. HE HAD TO DRIVE CUT & TOWARD THE EXIT).
