

Brief Details.

On 02.11.2022, at about 1015hrs, I have parked my vehicle bearing reg no SCK9779J at the open space car park, lot number 265 of Blk 1002 Jalan Bukit Merah Singapore 159456.

At about 1630hrs, I came back to my vehicle and noticed that there were scratches on my vehicle's rear left bumper. I also noticed that there was paper left on my vehicle's windscreen stating that earlier, there was a minor accident involving two vehicle (SKW303A & GBF9062G) and to check my bumper.

I made a check on my vehicle camera and discovered that at about 1200hrs, there was vehicle bearing reg no SKW303A parked at lot 266, just behind my vehicle. However, when the vehicle was about to exit the carpark lot, there was another van bearing reg no GBF9062G travelling straight, and both vehicles collided. When the collision took place, my vehicle camera captured that the vehicle SKW303A had hit onto my vehicle's bumper. My vehicle camera also shows that there was an impact.

I wish to state that there were no contact details left by the driver of SKW303A. Hence, I am lodging this report to seek assistance.
