

Describe Circumstances of the Accident

On 21/11/2022 at 4.17pm, all road vehicles were waiting at the traffic light to turn left from Somerset Road onto Grange Road.

I was in the centre lane of the 3-lane road, and the Bus 972M (number plate SMB 3614U) was adjacent to me on the right most lane. When the traffic light turned green, all vehicles started to move. At the point of turning, Bus 972M went into my lane and its left rear side swiped my right front/part of my car causing a part of my wheel bumper to fall off. The bus did not stop and continued to drive off.
