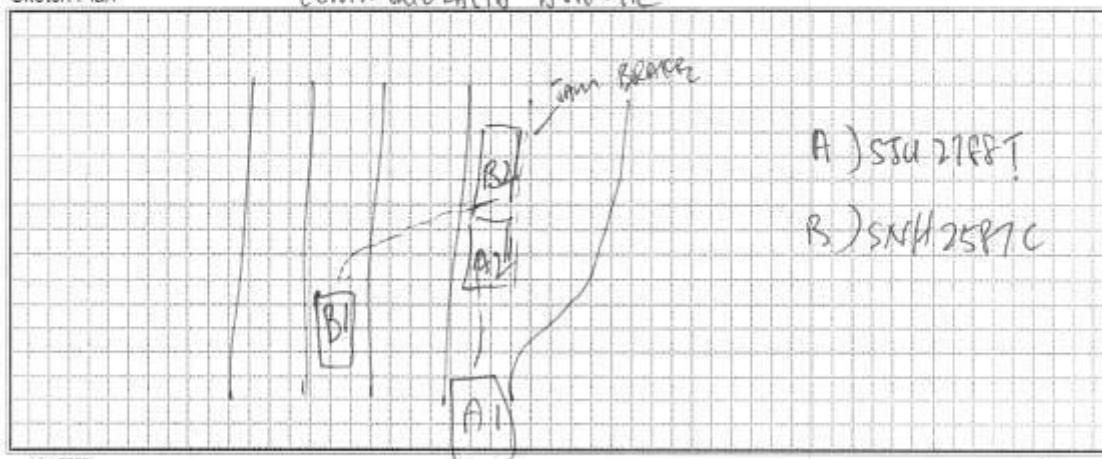

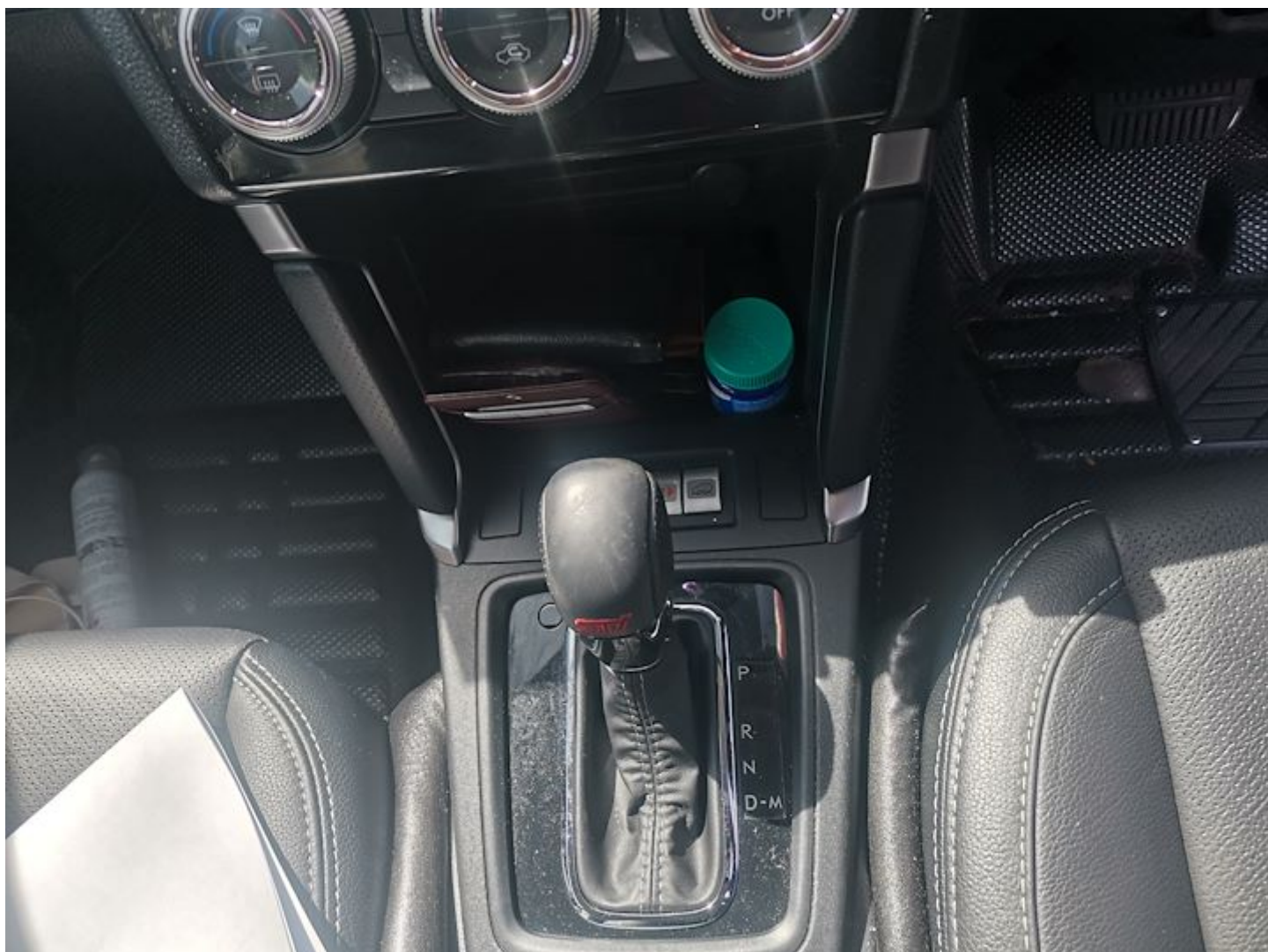

Brief Details.

On 23/11/2022 at 1830hrs to 1845hrs, I was driving along Commonwealth Avenue towards Queensway Road just after Commonwealth MRT. There was a BMW - (SNH2587C, Nav, 91172626) who had swerved from the 3rd lane to the 5th lane without signaling, the BMW wanted to turn at the lane heading towards Queensway Road and made a sudden emergency brake there were no cars in front of the BMW at that given moment. As it was so sudden, I did not manage to brake in time and had hit onto the back of his BMW. There are superficial scratches seen on both vehicles. When I had bumped into his vehicle, I immediately unbuckled my seatbelt and went out of my vehicle to check for the damages. However, when I went out of my vehicle the driver of the BMW was still in his vehicle. I then went over to his window and told him that I had hit on to his vehicle, only then did the driver of the BMW come out. When he had wind down his window to speak to me, I could also smell alcohol coming from his vehicle. The driver as he came out of his vehicle then said, "let the insurer handle this". We then exchanged contact numbers and left the accident scene.
