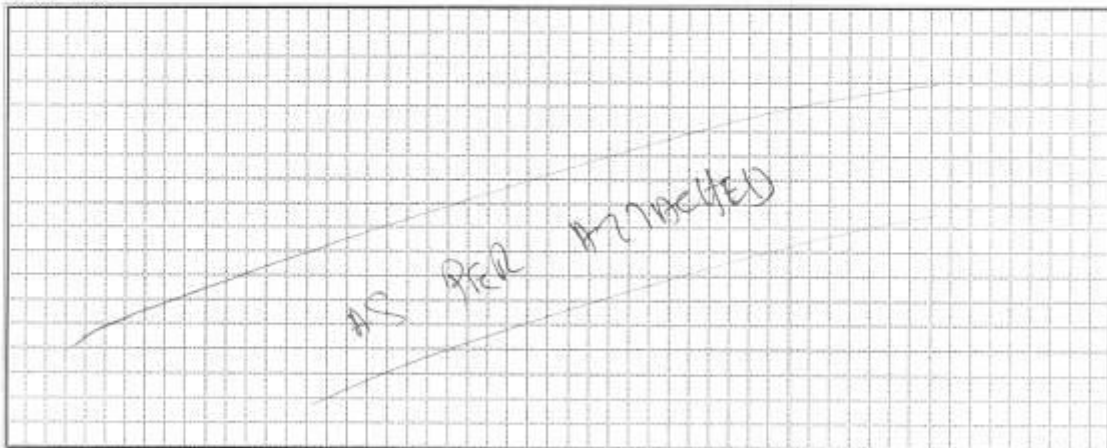


Sketch Plan

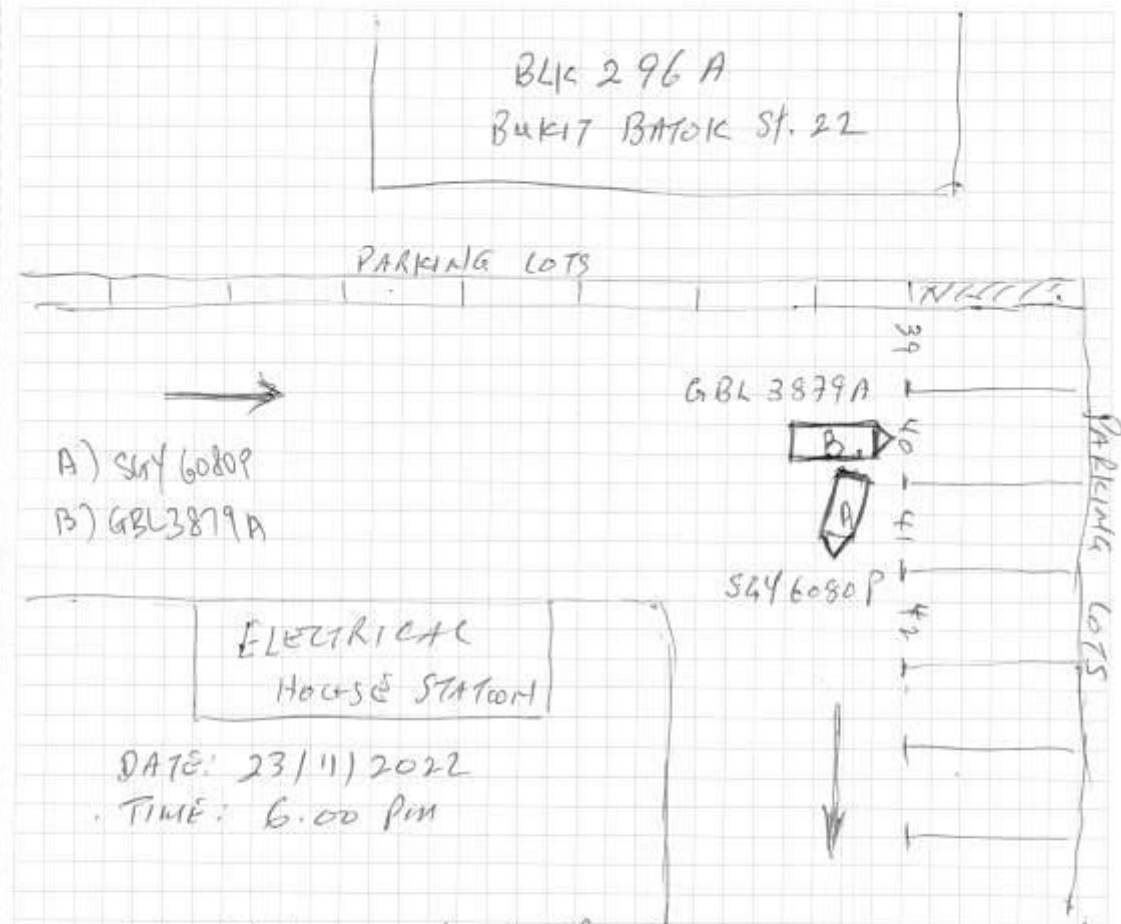
