

Surveyor Re-inspection Report:

The vehicle was stationary in a appropriate position for us to conduct our inspection after the repair performed by the vehicle owner preferred workshop. During our visual inspection, we focus at the impact area that was consistent with the accident. We noticed that the vehicle have yet to repair state. However, few items are in serviceable condition. There is a price difference of \$\$6,400.00 from the independent surveyor report that consist of parts that we viewed that was reusable. We have re-adjusted the repair amount that match our findings.

Our Recommendation

We re-adjust the cost of recommended labour/parts from \$\$9,810.96 to \$\$760.00.

For your understanding of our re-adjustment on parts and labour, the detailed listings are in the sections 'Parts Supply', 'Special Nett Items' and 'Labour Charges' above.

According to our re-adjustment, the recommended lump sum repair costs is \$\$760.00, which includes spart parts cost of \$\$30.00 and labour cost of \$\$920.00 on lump sum basis. We would state in conclusion the claim for the repairs to be considered at \$\$760.00 on a lump sum repair basis, with the repair period of 4 working days. In addition, attached are the photographs of the repaired vehicle taken during the reinspection.
