**Brief Details.**

On 17/02/22 at about 1135hrs, I was driving vehicle registration number SMM1048J along Delta Rd towards Alexandra Rd. As the traffic light was on amber, I made a right turn at the junction when suddenly a motorbike registration FBR 7685J came from the direction of Lower Delta Rd towards Delta Rd. I applied the emergency brake however I was not able to avoid the collision. I saw the rider roll off the motorbike. I alighted from my vehicle, made a check on him and subsequently called the ambulance. I saw some abrasions on the left leg of the rider. I did not suffer any injury. The front part of my vehicle was badly damaged. The motorbike was slightly damaged. The accident was captured on my vehicle dash cam and the memory card was handed over to the Traffic Police officer at the scene.
