

We were driving along Clifton Vale which is a 1-lane road and there were no cars behind us. ~~See~~ As we were approaching the small perpendicular side road also called Clifton Vale, there was a black car SLP9422E which did not stop at the stop line and turned right and hit our car on our left. Both our front and rear doors on the left were damaged. We took photographs and have in-car camera footage when the other car SLP9422E hit us. According to the in-car camera, the accident happened around 12.32 - 12.33 pm.
