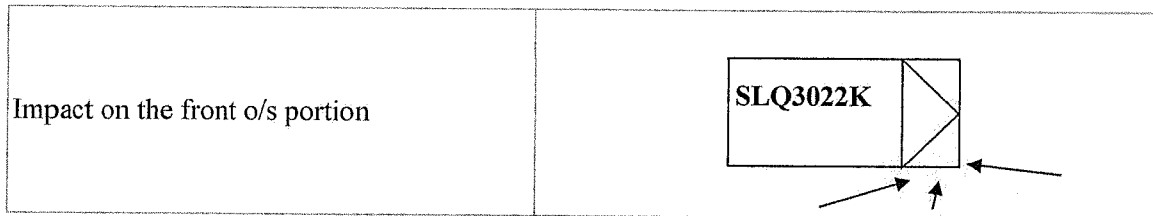

RECOMMENDATION

The estimate cost of repair submitted by Messrs Providence Automobile Pte Ltd as per schedule attached has been revised and scrutinised, and in our opinion, we consider it to be fair and reasonable. The repairers have agreed to undertake the repairs to the owner's satisfaction at our revision. We have not authorised the repairs.

Our adjusted cost of repair is SGD 8,400.00 to carry out the repairs. Please refer to Annex A (Appraisement Schedule) for a detailed account of the cost estimates.

REMARKS

We have not authorised the repair. However, for information, under normal circumstances, the repair would takes approximately 6 (SIX) working days to complete.

TERMS AND CONDITION FOR VEHICLES LEASING

We (hereinafter called "the Company" which expression shall where the context so admits include the owner's successor-in title) hereby agrees to lease the vehicle to the name driver/company named herein (therein-after called "Driver"/ "Company") agrees to below subject of the following terms and conditions:-

1. The said vehicle may only be driven by the lessee upon approval from the Company. Usage is strictly for own legal purposes only.
2. You must be in possession of a valid driving license and shall at all times drive the said vehicle in a careful and skilful manner, observing the traffic regulations and laws.
3. **DEPOSIT**
 - a. The lessee shall pay to the Company upon execution of this Leasing Contract a deposit ("the Deposit") the amount of which shall be determined by the Leasing Company.
 - b. The Deposit will be refundable in 5 working days upon returning the vehicle as in good conditions.
4. **PAYMENT**
 - a. The Price for the Vehicle shall be as stated in this Leasing Contract. The Lessee shall, in addition, pay all GST (if any) payable thereon at the prevailing rate.
 - b. The Lessee shall within make the payment on weekly basis. (apply for weekly basis)
 - c. The Lessee shall within make the payment on monthly basis. (apply for monthly basis)
 - d. Failing to pay **late charge** will be imposed at **\$20 per week** and interest of **5% per weekly** is apply. (apply on weekly basis)
 - e. Failing to pay **late charge** will be imposed at **\$80 per month** and interest of **5% per month** is apply. (apply on monthly basis)
5. **BREACH**

If the Lessee defaults in making any payment due hereunder or if he/she shall fail to observe or comply with any of the terms and conditions of this Leasing Contract herein contained (without prejudice to any other rights and claims the Company may consequentially have against the Lessee) the Company shall be at liberty to do all or any of the following without notice to the Lessee:

 - a. Terminate this Leasing Contract;
 - b. Towing back the Vehicle at Lessee own cost
 - c. Weekly / Monthly leasing is liable by Lessee in full till end contract. Deposit will be forfeited.
6. **INSURANCE**
 - a. The said vehicle shall be covered under a Comprehensive (COMP) / Third Party (TP) / Third Party Fire & Theft Insurance (TPFT) Policy only. (Singapore usage only)
 - b. An additional access for (COMP) of \$3,000 is liable for own damage and \$3,000 for third party claimed and \$214 for windscreen to be bared by the Lessee. As for (TP) Lessee will be liable for own damage claim and windscreen at full cost and \$4,000 for third party claimed. As for (TPFT) Lessee to be bared full cost liable for own damage claim \$3,000 access for third party claimed and full cost for windscreen to be bared by the Lessee.
 - c. To sign the overlap leasing agreement and shall immediately examine the state and condition of the vehicle, including the paint and body work of the vehicle, and shall forthwith notify the Company of any damage and / or defects whatsoever to the said vehicle.
 - d. Access payment has to be made in full immediately upon accident reporting
7. If fails to do so, you shall be deemed to have accepted and agreed that the vehicle is in all respects in a good physical condition, roadworthy, in a proper and safe working condition and fully equipped with audio equipment, fitting, accessories, tools and spare tyres.
8. In the event of any breach thereof, you (Lessee) shall bare all responsibilities of any **parking fines, demerit points and penalties** which may be incurred and shall also answer all **Police and Traffic Court Summonses, Notices and Inquiries** in connection therewith. Particular attention is to be accorded to the following :-
 - a. Vehicle must not be overloaded at all times.
 - b. To ensure the vehicle is clean and good conditions with sufficient radiator water, black/white smoke and the prescribed of tyre pressure. Tampering with speedometer is strictly prohibited.
 - c. Towing of vehicle break down to be bare by the Lessee
 - d. All tyres of ware and tare and tyres punctured to be bared by Lessee
 - e. Vehicle maintenance, repair and etc strictly only allow to our authorize workshop.
 - f. Shall not drive the said vehicle whilst under the influence of intoxicating liquor or drugs
 - g. It is expressly forbidden to allow the said vehicle out to third persons or to let unauthorized persons or learners to use the said vehicle or to permit the said vehicle to be used for illegal purposes (for instance : in connection with theft, drug pedaling or trafficking, smuggling or any other criminal activity) or the purposed of test or racing.
