ON 26/11/2022 AT AROUND 1645HRS, I WAS DRIVING VEHICLE A (SH7397S) ALONG BEACH ROAD. I WAS ON THE SECOND LANE TURNING LEFT INTO BRAS BASAH ROAD. WHILE TURNING LEFT WITHIN MY LANE, VEHICLE B (XE514Z) WHICH WAS ON THE THIRD LANE, COLLIDED ONTO THE FRONT RIGHT PORTION OF VEHICLE A. VEHICLE B IS A TOW TRUCK AND WAS TOWING VEHICLE C (UNKNOWN). 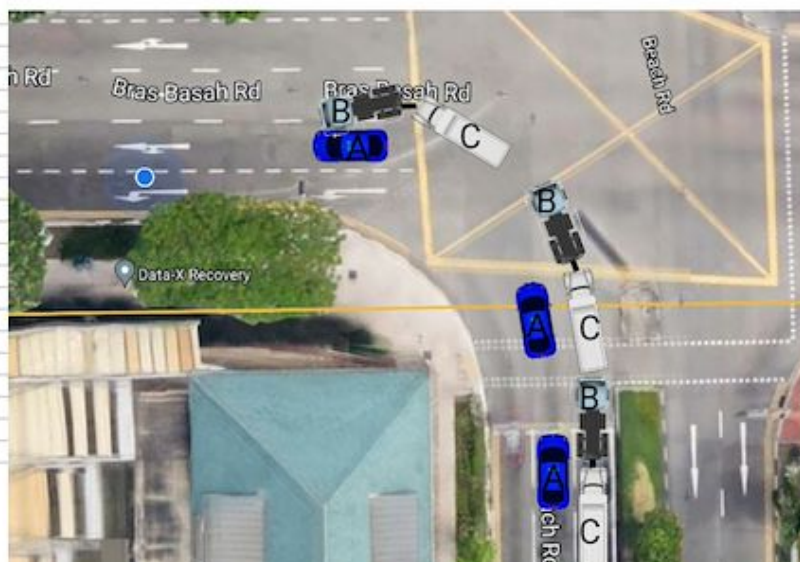

## Describe Circumstances of the Accident

ON 26/11/2022 AT AROUND 1645HRS, I WAS DRIVING VEHICLE A (SH7397S) ALONG BEACH ROAD. I WAS ON THE SECOND LANE TURNING LEFT INTO BRAS BASAH ROAD. WHILE TURNING LEFT WITHIN MY LANE, VEHICLE B (XE514Z) WHICH WAS ON THE THIRD LANE, COLLIDED ONTO THE FRONT RIGHT PORTION OF VEHICLE A.

VEHICLE B IS A TOW TRUCK AND WAS TOWING VEHICLE C (UNKNOWN). HOWEVER, THERE WAS NO COLLISION BETWEEN VEHICLE C AND ANY OTHER VEHICLES.
