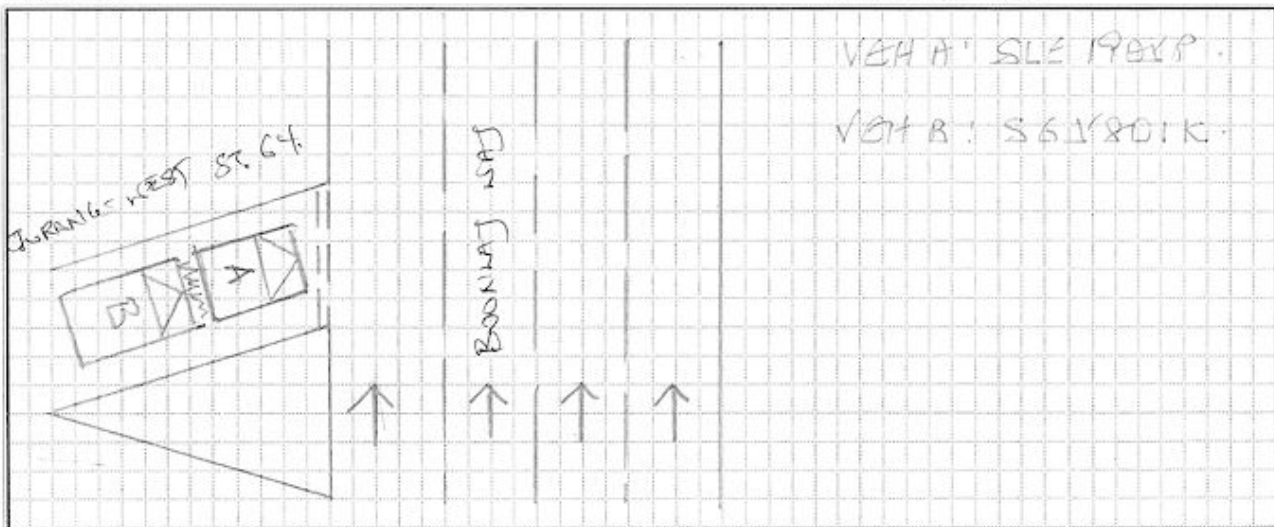

## Describe Circumstance of the Accident

ON 30/11/2022 @ 1305HRS, I WAS DRIVING MY VEHICLE A (SLE1905P) ALONG JURONG WEST ST 64 SLIP RD TO BOON LAY WAY. THERE WERE ONCOMING VEHICLES ON THE MAIN ROAD AND I HAVE TO STOP MY VEHICLE A (SLE1905P) ON THE STOP LINE TO CHECK CLEAR BEFORE PROCEEDING. SUDDENLY I FELT AN IMPACT FROM THE REAR OF MY VEHICLE A (SLE1905P). I WAS SHOCKED AND I SIGNAL VEHICLE B (SG5801K) TO DRIVE TO SIDE OF THE MAIN ROAD. I ALIGHTED TO CHECKED AND FOUND OUT THAT VEHICLE B (SG5801K) FRONT PORTION COLLIDED ONTO THE REAR OF MY VEHICLE A (SLE1905P). WE THEN EXCHANGE PARTICULARS FOR INSURANCE CLAIM.
