


Figure 1A: Schematic Diagram




Figure 1B: Schematic Diagram




Figure 1C: Schematic Diagram




Figure 1D: Schematic Diagram




Figure 1E: Schematic Diagram




Figure 1F: Schematic Diagram




Figure 2B: Rear View of MID 28




Figure 2E: Front View of MID28 at Incident Location




Figure 2F: Contact between SKR838A and MID28




Figure 2I: Rear view of SMD5130A in front of MID28 (final position)
