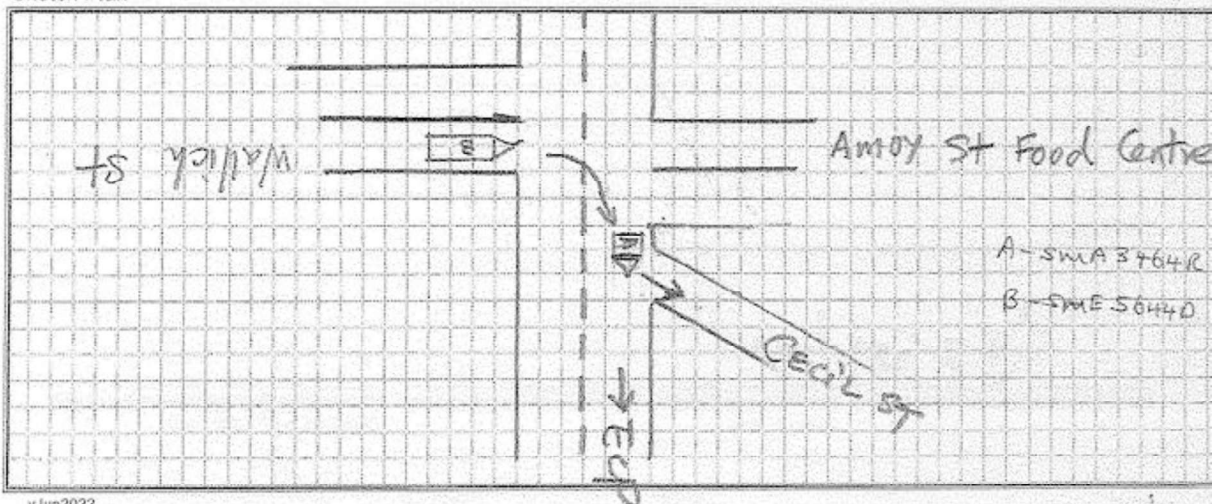

NOTICE OF REPORTING

This is to confirm that Tan BoonWah H/P: 93366300, NRIC/FIN: S1607428D has reported to the Police a non-injury traffic accident which occurred along Maxwell Road on 27/11/2022 at 1145hrs involving the following vehicles:

- A) SMA3464R – Complainant's vehicle
- B) SME5644D – Other party vehicle

On 27/11/2022 at 1145hrs, I was traveling along Maxwell Road turning left into Cecil Street. Later, I felt an impact on the right side of my vehicle. I then made a check and discovered that a vehicle (SME5644D) turned right from Walich St and hit onto the right rear side of my vehicle. Both of us then exchanged particulars who the other driver insisted that it is my fault and will be claiming insurance against me.
