Brief Details.

The morning traffic was slow but moving with cars close to each other front and back, I was driving along Woodlands Ave 12 (fully on lane 2 all the way, onto Exit SLE towards CTE), slowly closing the gaps in front of me and anticipating on the car on my left front filtering into my lane, Car SLK2453M bang into the back right of my car (SGQ3375B). Driver of SLK2453M failed to form up to traffic to exit (driving on chevron to filter), and failed to keep safe distance from vehicle in front

No immediate injury was noticed, until 1st Dec morning, there is muscle ache on the right back muscle, no pain on lower parts and other parts of body as of this report.

I consulted GP for advice and was given medication and 3 Days MC.
