**Brief Details.**

This report is made to be reference to another report with the report number of "J/20221128/0157".

On 2305hrs, 28 November 2022, I was riding my motorcycle (Vehicle Detail, Brand: Honda, Model: DASH 125, License Plate No: JUJ2517, Color: Blue. Driver Particular, Name: Lim Weng Keong, FIN No: G8303351M, Mobile Number: 87628522, Vehicle Insurance Company: Allianz General Insurance Company (Malaysia) Berhad, Vehicle Insurance Number: AEJB0528453) on my way from my workplace back to my home in Malaysia, riding along Woodlands Avenue 9. I was on the second lane and on the right side of me there was a lorry. When the traffic light turns green the lorry was in front of me. When the lorry started to turn and move to the right side, there was also another car that was turning and moving to the left at the opposite lane. While I was riding, I suddenly saw until the opposite car (Vehicle Particular, Brand: Toyota, Model: WISH, License Plate No: SLF4684B, Color: Silver. Driver Particular, Name: Low Chit Shin. NRIC No: S2550496H, Mobile Number: 9710 8361) that was moving, I

quickly jam the brake, but the road was wet and slippery which causes me to hit until the left side of the car. I was knock out of my seat because of the impact and hit until the left side of the car rear, before felling flat on the floor. The car that was moving, move a bit before stopping that causes me to collide with it. After the collision, there was an Ambulance at the opposite lane, the ambulance ride over and carry me to a nearby bench for me to rest and call Khoo Teck Puat ambulance to bring me to hospital. They bring me to Khoo Teck Puat Hospital and arrive there at 0000hrs, 29 November 2022 and was discharged at 0243hrs, 29 November 2022. And was given 3 days MC.

My motorcycle became seriously damage as almost the front half of the vehicle is broken and the motorcycle key is slanted to one side, for the car there is some slight dent on the left side of the car after the collision.
