### **8. Consent under the Personal Data Protection Act (PDPA)**

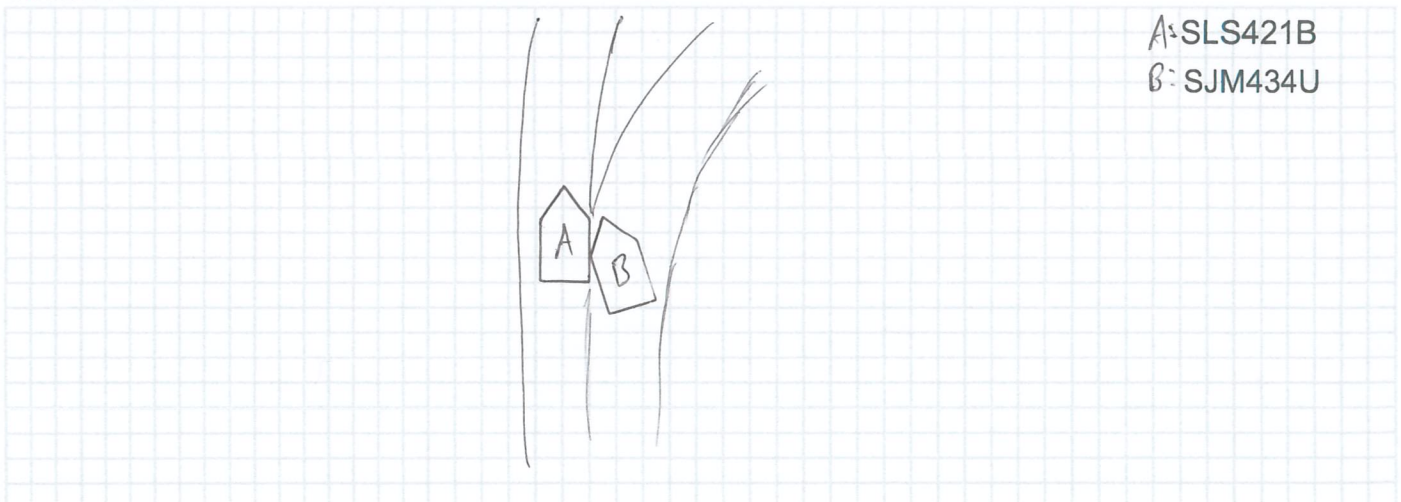

**Sketch Plan**

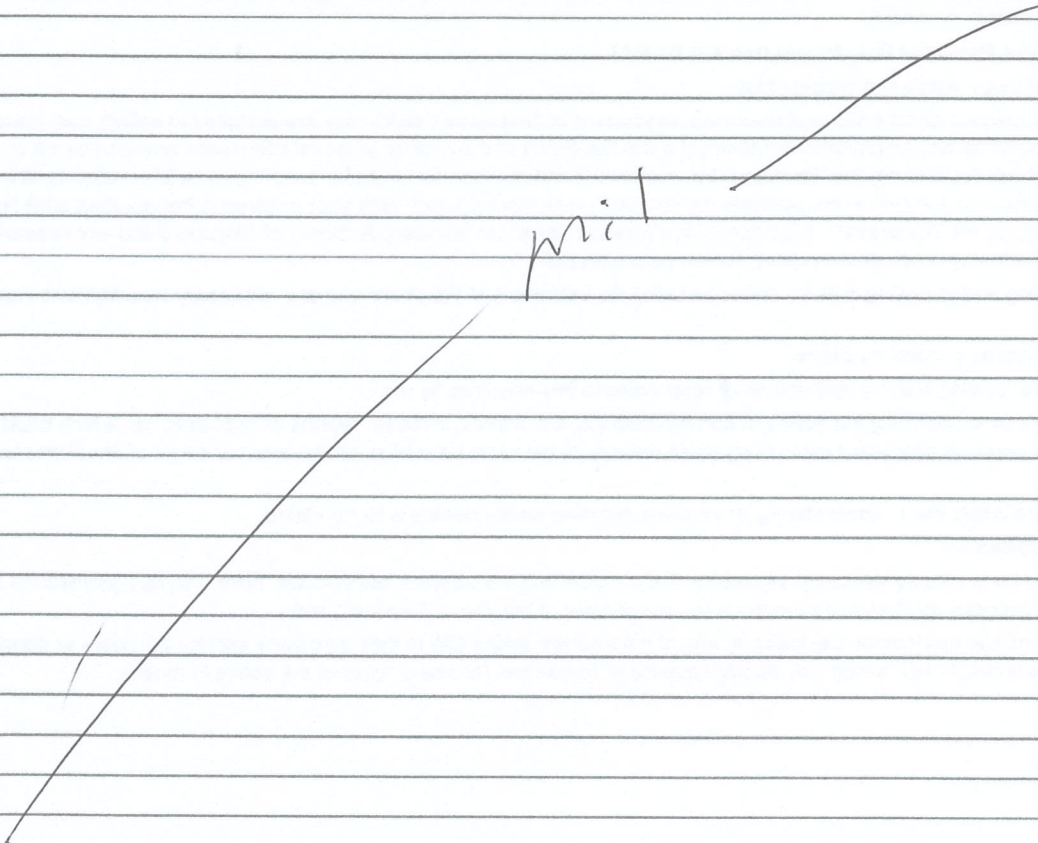

**Describe Circumstances of the Accident**




