I am the driver of CNB vehicle QX998T and I was the driving the car on the way back to Police Cantonment Complex from Changi Prison. I was on the second lane of the ECP heading towards MCE near the Fort Rd exit. I was driving at about 70 to 80km/h, I couldn't remember exactly.
