Brief Details.

On 27 Nov 2022, at about 1741hrs I had fetched a friend from Tiong Bahru Plaza and was riding my motorcycle bearing plate number FBF967E along Tiong Bahru Road towards Outram Rd (Near Shell petrol station) with a pillion. Upon reaching a cross junction, I was in the middle of the cross junction when a BMW (SMF5228S) came out onto the junction from my left. The car hit my front left side of the bike. My bike turned towards the ride and my pillion and I fell onto our left side. The driver then came out of his vehicle and assisted use to move onto the side of the road while a passerby called for the ambulance. Traffic police also attended to the incident.

The speed i was travelling at was approximately 40-50km/h as it was a bend prior to approaching the mentioned cross junction.

I was conveyed by ambulance to Singapore General Hospital. I suffered abrasions on my top left feet, left shin, left knee, left elbow and left shoulder. My pillion suffered abrasion on the
