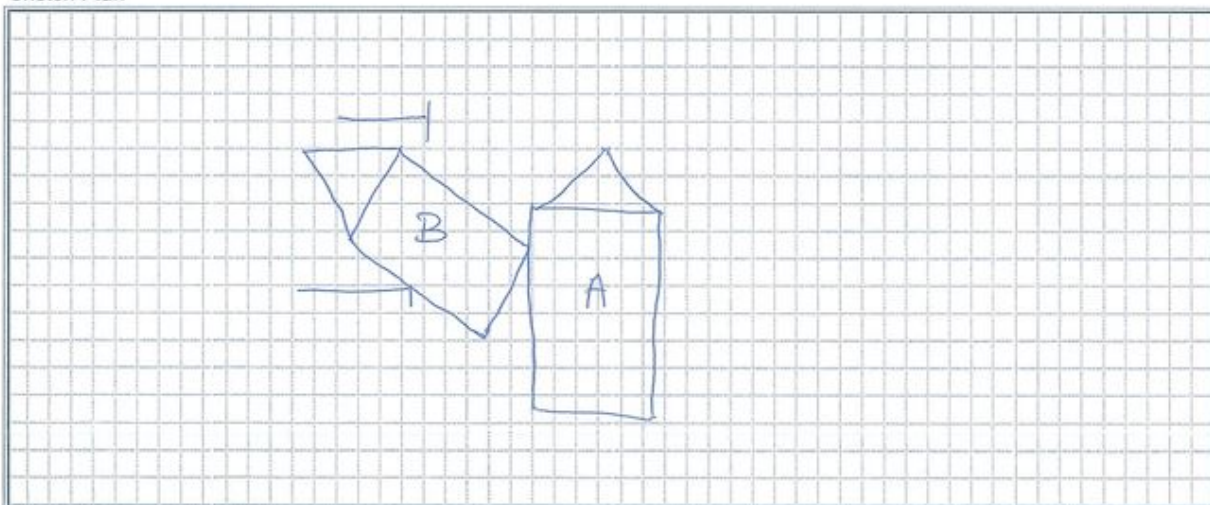

my vehicle was stationary when vehicle B reverse and collided onto my door.

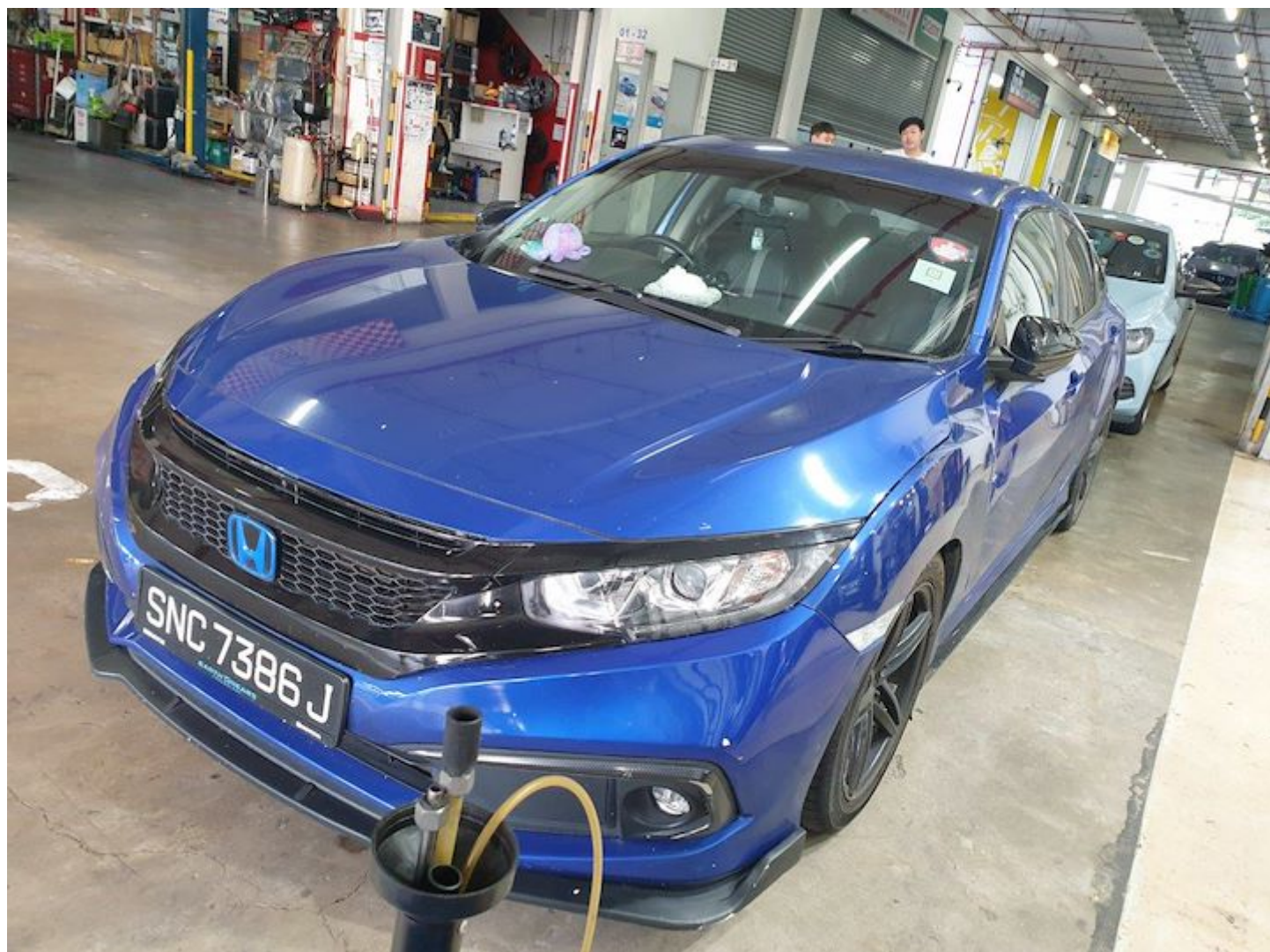

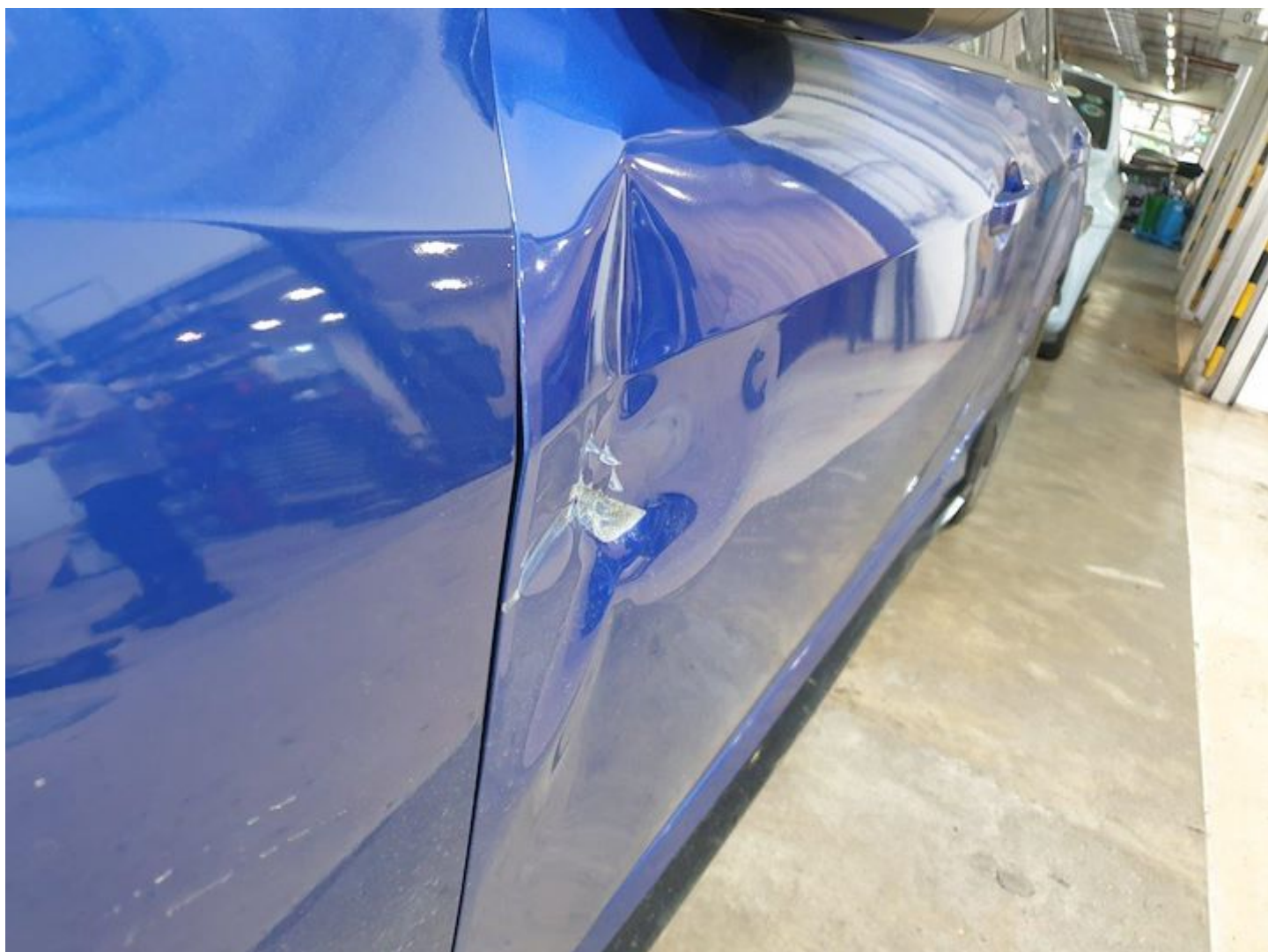

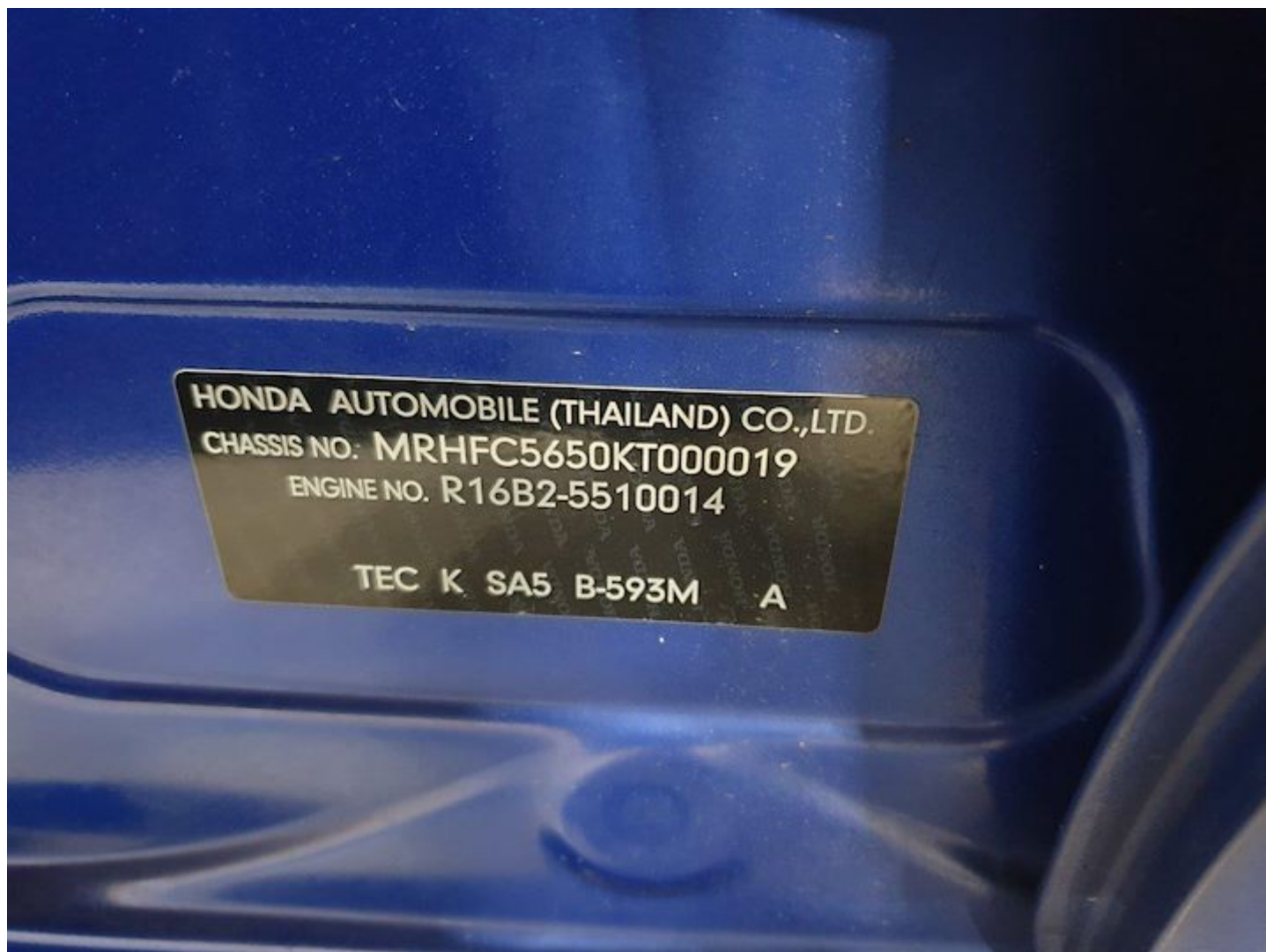
