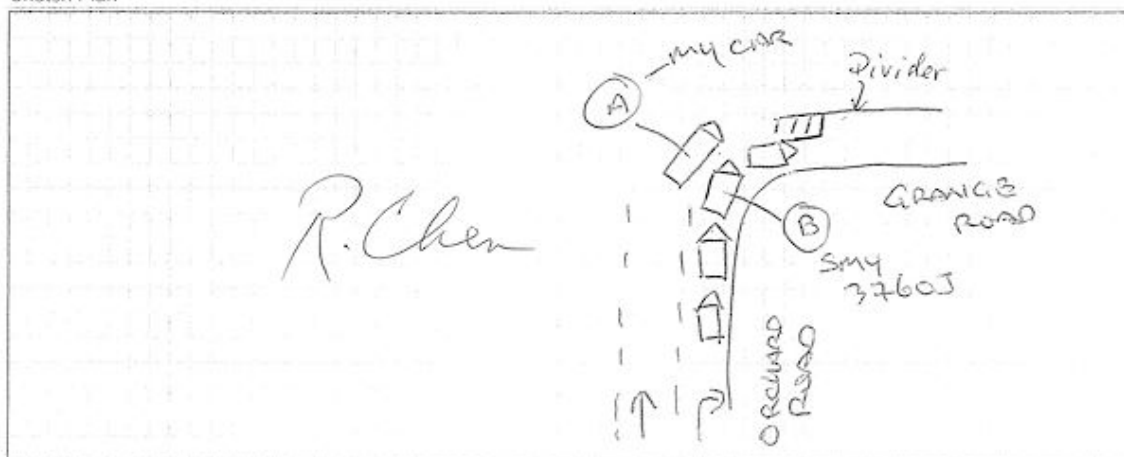

ON 02.12.2022 AT ABOUT 4.30PM, I WAS TRAVELLING ALONG ORCHARD ROAD TOWARDS GRANGE ROAD. THERE WAS A SEVERE TRAFFIC JAM. AS I TURNED RIGHT THE CAR ON MY RIGHT UNEXPECTEDLY MOVED OUT TOWARDS MY RIGHT. HE WAS PERFECTLY NORMAL, NOT IN PAIN, SPOKE CALMLY AND SHOWED NO SIGNS OF INJURIES.

ON 03.12.2022 I ASKED MY WORKSHOP, TAN CHONG MOTOR, TO ASSIST ME TO CALL MR JIMMY GOH THE OTHER PARTY INVOLVED IN THIS ACCIDENT. TAN CHONG CALLED MR KOK HOW (JIMMY GOH'S WORKSHOP) H/P: 87781765. I WAS INFORMED BY MR JIMMY GOH'S WORKSHOP, THAT HE WAS INJURED AND CLAIMING INJURIES VIA HIS LAWYER. AS HE IS CLAIMING BODILY INJURY WHICH HE DID NOT SUSTAIN, I CANNOT MAKE A PRIVATE SETTLEMENT WITH HIM. HENCE, I AM FILING THIS AS A "REPORTING ONLY".
