I remember clearly that I was driving towards the X junction of Orchard road and Grange road. I was on the most right lane, making a right turn into Grange road. Just as I was halfway through the turn, a vehicle bearing SKU1255J made a right turn on the lane beside me which is a go straight only lane, colliding onto my vehicle. We alighted our vehicles and exchanged our particulars. I took a few photos and left the scene as my passenger was waiting at Ngee Ann City. I started experiencing discomfort when I was sending my passenger to their destination. I wish to state that the said collision rocked my vehicle and I felt discomfort due to the sudden jerk. Thinking I might recover after a day rest, I went home to rest for the day. However, the discomfort and pain persist and I proceeded for a medical consultation for precautionary measures. I was then given 2 days MC and advised to proceed for further follow up should I continue to experience pain and discomfort.
