# SKETCH PLAN

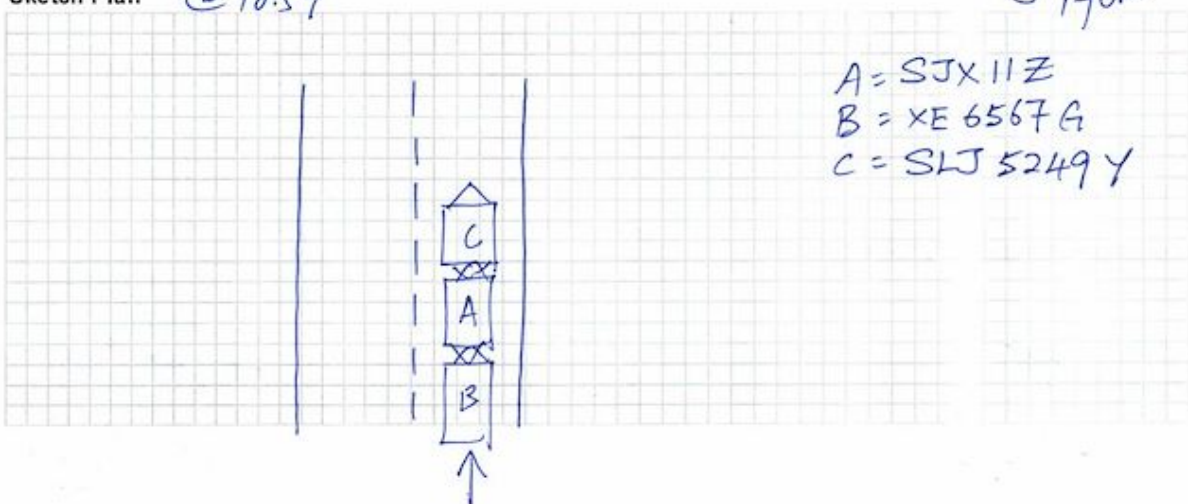

It was about 5.50 pm on Monday 28<sup>th</sup> November 2022. It was not raining and the road was dry. My vehicle SJX 11Z had come to a halt on the right turn lane behind Vehicle No. SLJ 5249Y along Gul Road, queuing at the traffic light junction before Pioneer Road and the traffic light was then RED.

Just when the traffic light turned GREEN, trailer XE 6567G driven by Chee Eng Wah (NRIC No. 7407229A) slammed into the rear of my vehicle and the high impact caused my vehicle to search forward, thus hitting the rear of Vehicle No. SLJ 5249Y driven by Kang Chee Weng. No one seem to be injured because of this accident.

On my observation at the scene, I noticed that both the rear and front of my vehicle were badly damaged.
