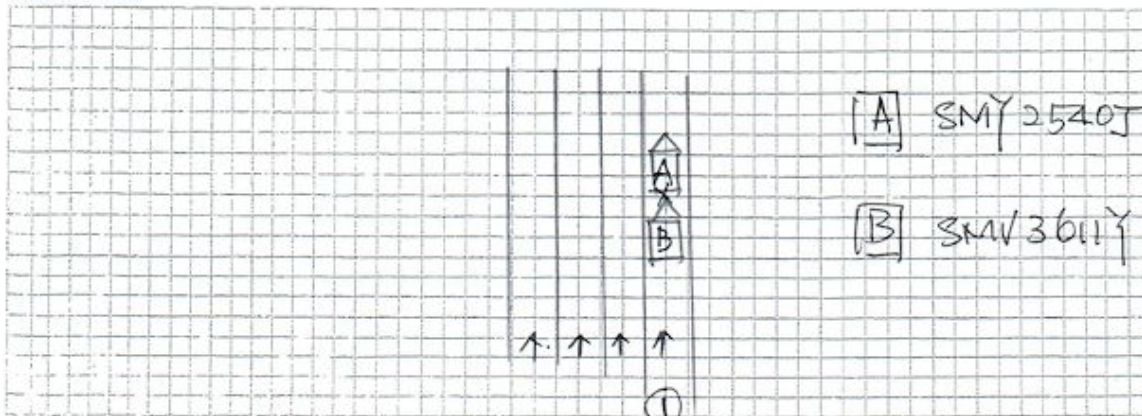

Sketch Plan



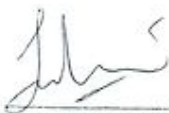
PIE TOWARDS CHANGI AIRPORT.

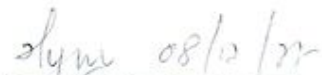
