AS VEHICLE A WAS APPROACHING THE TRAFFIC LIGHT JUNCTION, VEHICLE A NOTICES THE GREEN ARROW WAS IN VEHICLE A FAVOR. VEHICLE A PROCEEDED TO MAKE A RIGHT TURN INTO BUANGKOK CRESCENT. WHILE VEHICLE A WAS ENTERING INTO BUANGKOK CRESCENT, VEHICLE A FELT A STRONG IMPACT FROM THE LEFT AND REALISED VEHICLE B HAD COLLIDED ONTO VEHICLE A LEFT FRONT WHEEL SIDE. 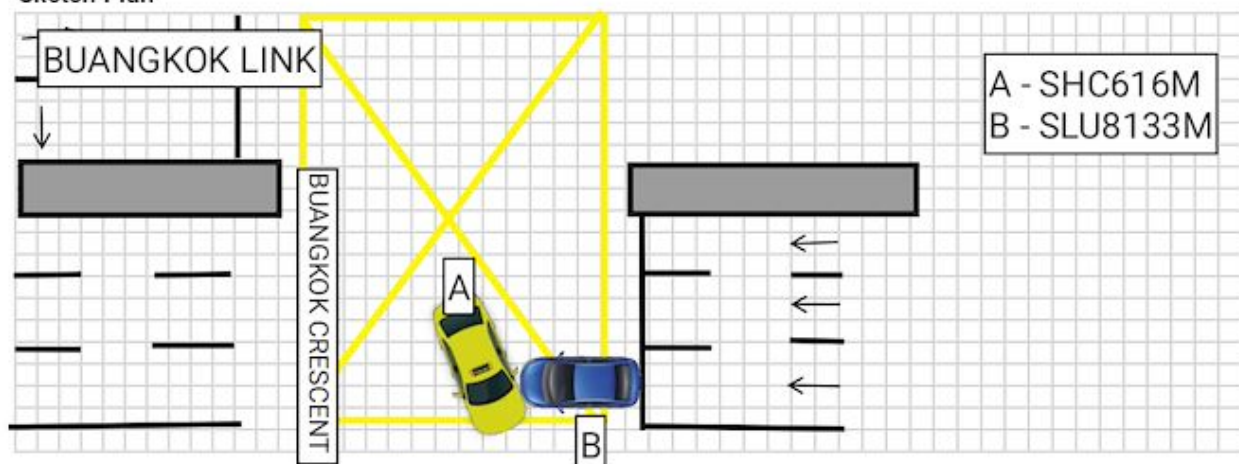
