- 1. I am working as business development manager with Biscotti. I am also one of the director and shareholder of Biscotti. The other directors are my family members.
- 2. My scope of work is mainly sales. I will meet client outside the office and monitor sales in the market. So I travel quite lot out of office.
- 3. In the morning, I also help with loading and unloading at the company's premises which is at Tampines.
- 4. The car SMF 2318K is assigned to me by the company as I need to travel for my work. I use it mainly for work but I also drive the car home and use for personal use after working hours.
- 5. The outgoings like parking, petrol, and service of car are paid by the company.
- 6. I cannot remember when I first got the car or how long I have been using. I think it's a few years but less than 5 years. My sister (company director) was the one in charge.
- 7. The car is serviced by Borneo Motors, I will send the car for serving when it is time for servicing either by the distance travelled or when I get a call from Borneo Motors.
- 8. On 2 March 2022 I cannot remember what happened on that day before the 2<sup>nd</sup> accident.
- 9. I can remember the 2<sup>nd</sup> accident. This accident was at Circuit Road area. I remember that I was looking for new customer around that area. I was driving around the Circuit Road area to look for suitable shops who are willing to carry my company's biscuits. When I see a suitable shop, I will park my car and then go and talk to owner of the shop and introduce myself and my company's products.
- 10. I cannot remember how long was I driving around. But I do remember that on that day I was not taking orders or doing delivery. So I should be driving around looking for business after I helped with loading and unloading at the company's premises.
- 11. I cannot remember whether I had lunch that day or where I had lunch that day.
- 12. I cannot remember the first accident or if I was at the first accident location. I only mention  $1^{st}$  accident because the loss adjustor Naaz showed me the video at the meeting with him. Then I discussed with my sister and we filed the GIA report because there is video shown to me.
- 13. I cannot remember the first accident at all.
- 14. Regarding the second accident, I remember that that a bus came of the bus bay before the junction. I think I was still looking at the mirrors to see if there was any contact and I was not looking forward. So my car proceeded into the junction unknowingly.
- 15. After the accident, I saw a taxi in front and there was damage on the taxi. I would like to clarify that my car did not hit the lamp-post. It was just very near to the lamp post.

- 16. The airbag in my car for the driver was activated. I cannot remember if the front passenger airbag was activated. I remember I felt dizzy during the collision but I am not sure if my head hit any thing.
- 17. I remember 2 different officers came down but I am not sure if they are from TP or LTA. They did not take my SD card as there was no government property damage. I did exchange particulars with the taxi driver. I was allowed to leave after that.
- 18. I called towing and then it started to rain. I was wet. After that I went home, I cannot remember if I took taxi or some one come and fetch me.
- 19. I made the GIA report the next day.
- 20. I did not go to work the next day. After making the report I went home. I was resting at home.
- 21. Some time in the evening I had severe stomache and I think my daughter called my sister to come over and they called the ambulance.
- 22. I was hospitalised until 8 March 2022.
- 23. I was discharged on 8 March 2022 and loss adjustor Naaz saw me on 9 March 2022 I did tell him that I cannot remember a lot of things. He told me to say what I can remember and say what I cannot remember in my statement to him.
- 24. To date there is no action from TP. My car is still at the Borneo Motors workshop pending AXA approval for repair.
- 25. I have shown the first accident video and the photos in the 2<sup>nd</sup> accident GIA report. I note that front left tyre is a spare tyre.
- 26. I do not recall changing tyre but I believe that logically I should be the one who changed the tyre. I also believe that the tyre should have been changed on that day because I will not let my wife drive the car with the spare tyre.
- 27. I remember that the trye of my car was last changed at a tyre shop in woodlands.
- 28. My view is that spare tyre can be used for a few hours since its not for long distance.
- 29. I believe that my intention was to go to the tyre shop to change the tyre after the rounds at Circuit Road.
- 30. I remember i had changed the tyres of several vehicles. It is not a difficult task. I have also driven a vehicle with spare tyre in Malaysia for while (from another state back to my home) on a highway. So I have some experience driving a vehicle with spare tyre. There is no problem if not a fast speed is maintained.

- 31. I do not have any medical condition. Even after the discharge from CGH I remember I was not given medication for high blood pressure. I am not on any medication at the moment. I confirm that before the accident I did not have any medical condition.
- 32. I am not sure why I cannot remember what happened before the 2<sup>nd</sup> accident. I was not even aware of this until the loss adjustor showed me the 1<sup>st</sup> accident video at the interview on 9 March 2022. It was only then that I realised I did not have any recollection of the matter shortly before the 2<sup>nd</sup> accident.
