I hereby declare that the following statement is voluntarily made by me for insurance purpose.

I am the abovenamed person.

I am the Director of Biscotti Trading Pte Ltd, which I had set up in the year 2013 with my husband. The company's business deals with the sale of biscuits to supermarkets and minimarts, amongst others.

The vehicle bearing registration no. SMF2318K, a Toyota Prius, was purchased under the company's name and for my brother Loo Chun Yik to use in his role as a Sales Executive cum Director of the company.

The vehicle was purchased on a 1st hand basis from Borneo Motors in October 2018 and it is under a hire purchase agreement with Hong Leong Bank.

The servicing and maintenance of the vehicle would be carried out at Borneo Motors in Ubi, with the last servicing carried out on 6 December 2021.

My brother has been employed with my company for about 6 years and his main role is to perform sales work for the company.

My brother would normally report at the office in Tampines at 0830hrs and he would first help me to load as well as supervise loading of goods for delivery onto lorries until about 1030hrs to 1100hrs. This would be followed by him heading to perform his sales work, with different areas travelled each day. I would know where he would head to as there are different designated areas of service each day.

On Wednesday 2 March 2022, my brother had reported for work at about 0845hrs and he had helped with the loading supervision duties until about 1000hrs. He did not appear to be ill or unwell in any way when he was at the office, all the way until about 1000hrs to 1015hrs. He had thereafter left the office and to the best of my knowledge, he was due to service some customers in the Little India area until after lunch. This was to be followed by him delivering 2 sets of orders to customers in the west side at the Bukit Batok area.

I did not receive any call from my brother between 1200hrs to 1500hrs that day and I was not any time informed that he had been involved in the accident at about 1200hrs. It was only at about 1550hrs that I had received a call from my brother and he had informed me that he had been involved in an accident involving a taxi along Circuit Road as well as



that the vehicle had almost hit a lamp post. My brother had also informed me that he had hit his head over the course of the accident and that he had felt like fainting. The police officers who had later attended to him had informed him that they could activate an ambulance for him but he had replied that he had wanted to rest and that he would seek medical treatment himself if needed. My brother was coherent when he had spoken to me and when I had asked him if he was injured, he had replied that he was fine. He had also stated that the vehicle had sustained serious damage and he had sent me some photographs of the damage. I do not know what my brother was doing at the Circuit Road at the time but I believe that he may have been visiting some customers in the Macpherson area.

I had then contacted the insurance agent from Meta agency and he had advised me to contact Borneo Motors. My husband had later helped me to activate a tow truck for the vehicle and it was at about 1830hrs towed from the accident scene to Borneo Motors in Bukit Merah. My brother had left the scene after the arrival of the tow truck left the area and I do not know where he had gone thereafter. He did not call me that evening or night either.

My brother had on the next day reported for work at about 0900hrs and he had appeared to be fine, although he had mentioned that he may have been tired due to lack of sleep. My husband had then assigned him to do some simple work such as checking stocks and loading, with him told to wait until we could inform him where to go to report the accident. He had subsequently left the office at about 1030hrs and he had headed to Borneo Motors in Pandan, where the vehicle had been moved to, himself by MRT.

On the same day at about 1600hrs, my husband and me had picked my brother up from Borneo Motors in Pandan. He had appeared to be fine at the time and we had thereafter picked up his son from the student care at Serangoon, after which we had sent them home. We had dropped him and his son off at about 1800hrs, following which we had headed home.

On the same day at about 1930hrs, I had received a call from my niece and she had mentioned that my brother was vomiting constantly due to gastric pain, as well as that an ambulance had been activated. I had then headed to my brother's home and I had spoken to the paramedics who were attending to him. My brother was then seen to be seated on a chair and he had kept on vomiting into a pail. The paramedics had subjected him to an ECG and his his heartbeat was abnormal while his blood pressure was found to be very high. I had later escorted my brother to hospital and I had informed the doctor of him being involved in an accident on the day before.


To the best of my knowledge, my brother does not have any known alcohol or drug consumption habit. He does not have any pre-existing illnesses and he also does not have any form of financial problems.

I consent to allow AXA Insurance Pte Ltd towards resolving any received Third Party claim at best.


