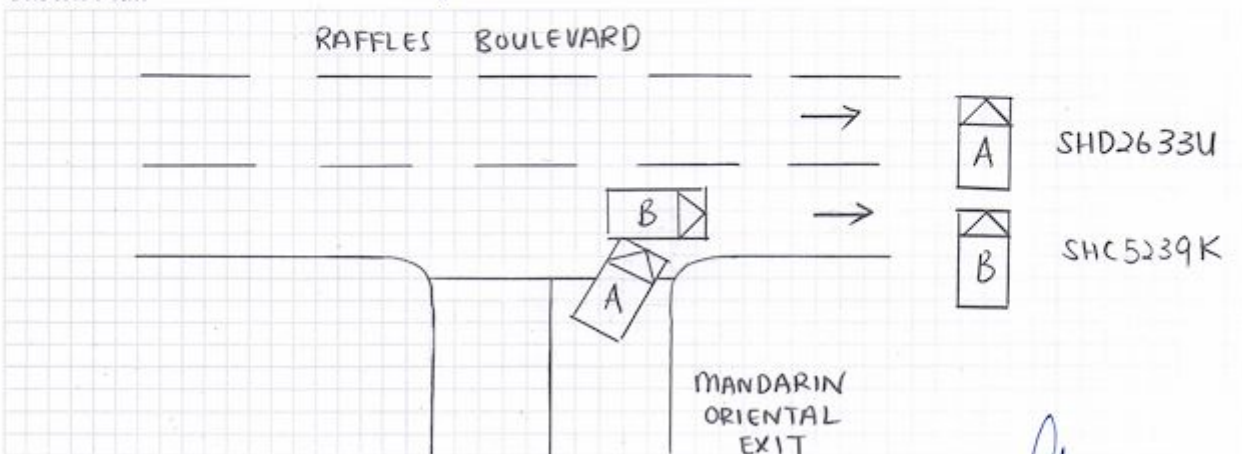

**Describe Circumstances of the Accident**

On 08.12.2022 @ 1732 hrs, I stopped my taxi SHD2633U along Mandarin Oriental exit to check for the oncoming vehicles along Raffles Boulevard (main road) . After checking traffic cleared, I proceed driving out. On my process of driving out, all of sudden one Trans Cab SHC5239K came from my left side and as a result its right rear portion grazed against my taxi left front portion.


After the accident, we alighted from our vehicles to check on the damages. We exchanged particulars. At the material time of the accident, no one was injured in this accident. However on the same day night time, driver of SHC5239K (Mr. Calvin) called to inform me one of his passenger was pain on his hand so he might go to see doctor if pain persisted.
