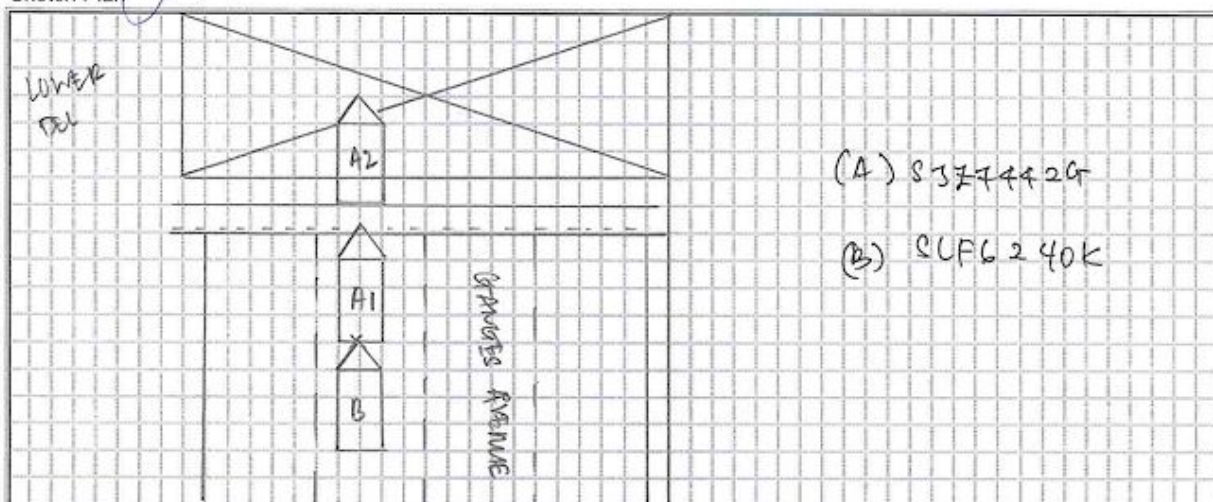

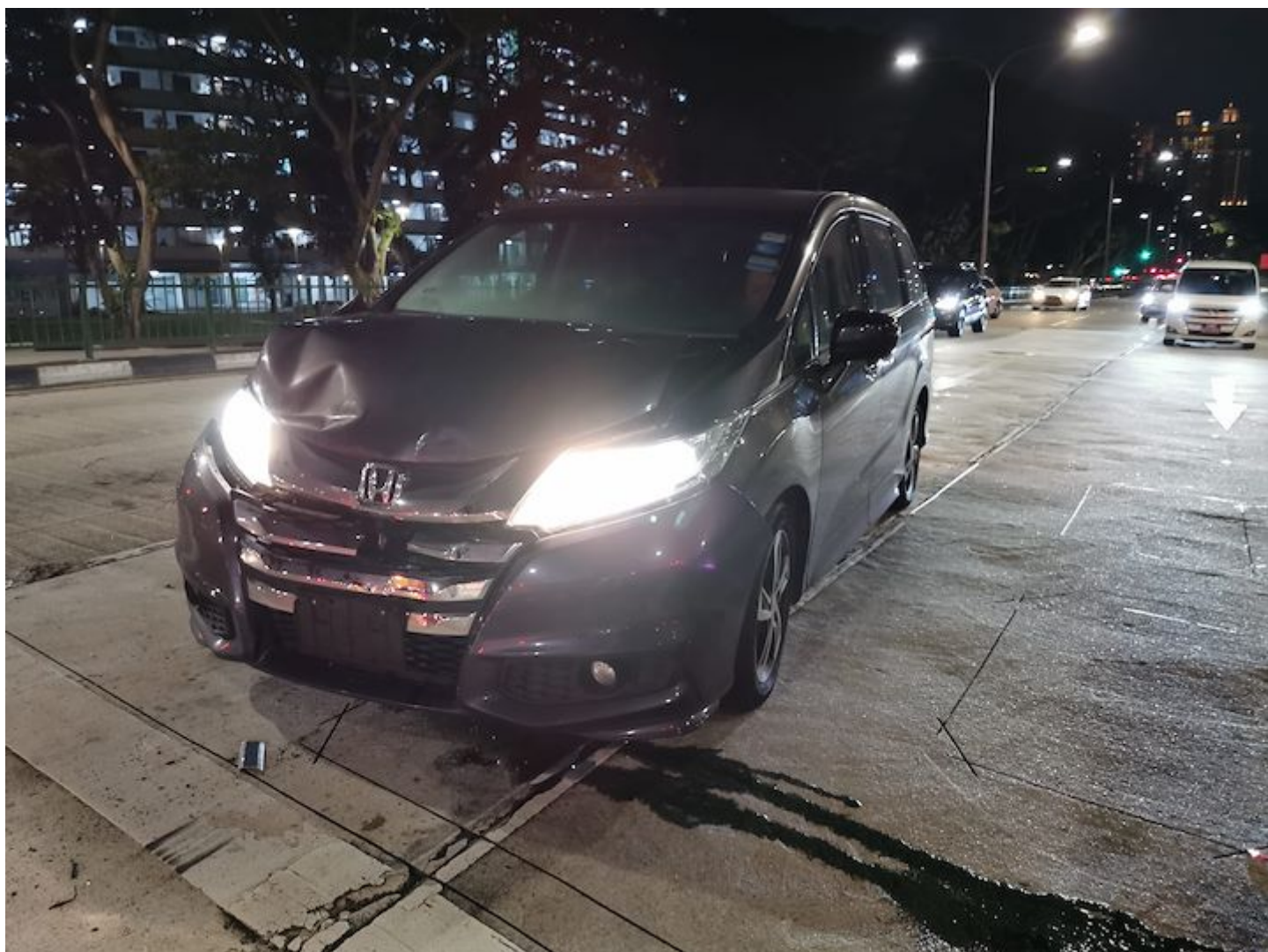

Sketch Plan





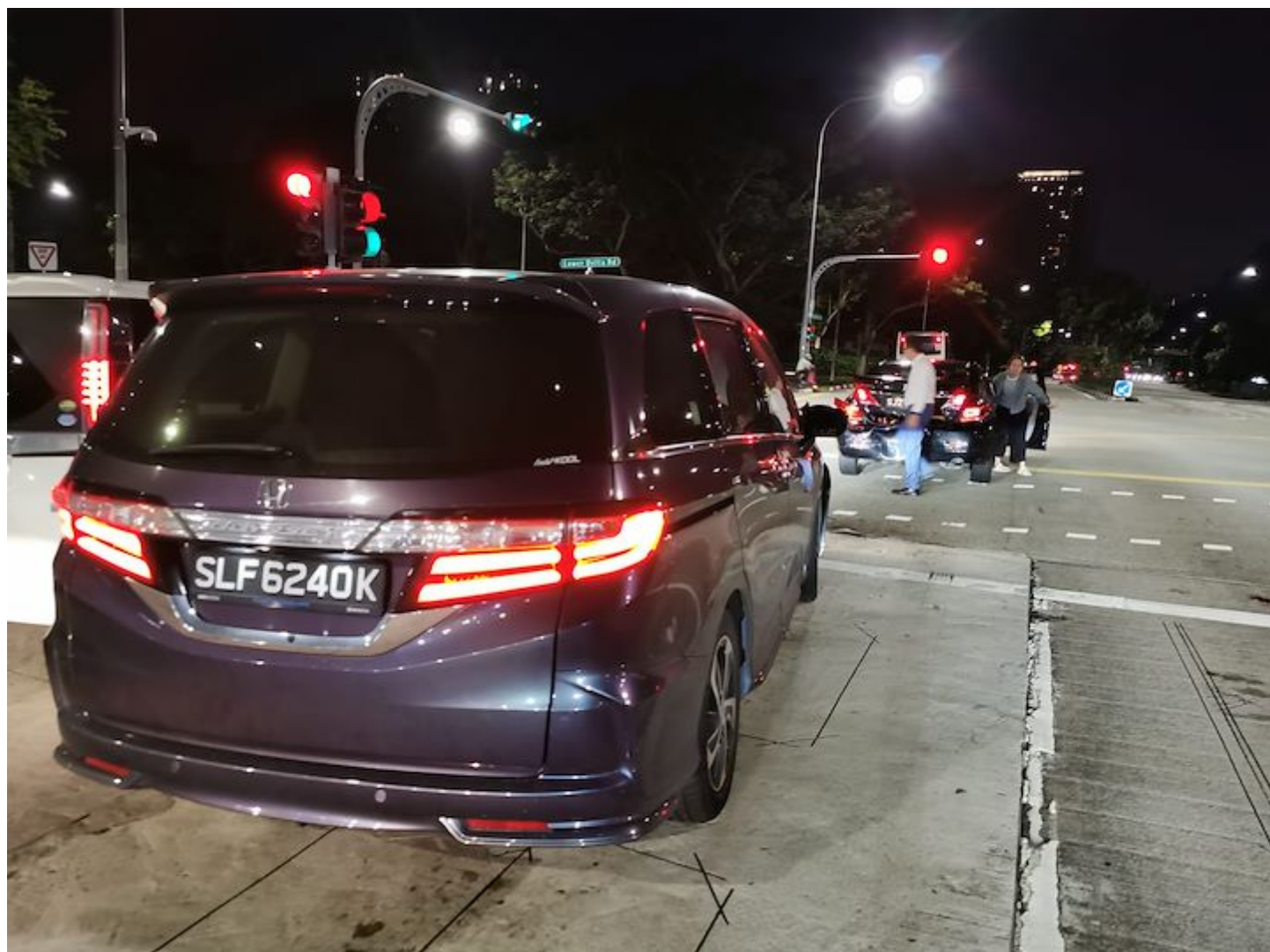
