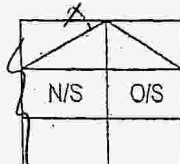

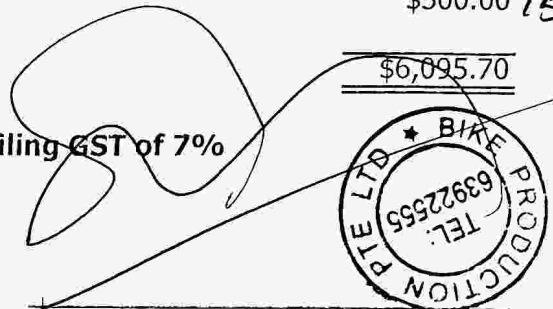

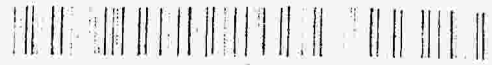

SL1309D driven by Mr. Hui Guk Tong S1561851E from my side mirror.

I turned my handle to my left to avoid being dragged forward and the car on my left also stopped immediately. I fell to the ground when my left foot gave way and I swerved to the left while my bike came off my leg. I tried to stand to free my leg but did not manage to stand up. I dragged it out from under my bike and sat down on the floor to regain composure.

When I turned my head, the taxi driver was standing beside me with other passerby and he grabbed my hip from my bike to stand and passed it to me. I asked for help to make a call to 999 but he assumed I had called his plate when he passed my hip. He kept telling passerby the police have been called and I was still in a daze.

A passerby shifted my motorcycle and asked if I can stand to move to the side. I could not move my leg and did not have the strength to get up. I was assisted up and move to the side. I asked the taxi driver if someone have called the ambulance and he replied, "You called 999 already right?". I said no I didn't call anyone.

On at 3.51pm I dialled 999 and asked for assistance. By then I was feeling giddy and could not keep my head up. I was feeling pain on my left hips, thigh, back, hands and ankle. I also managed to contact my spouse as well.

The ambulance arrived and I was attended to before they brought me to NTFGH. I passed my motorcycle key to the paramedic and my spouse arrived at the scene and collected my belongings from the bike.
