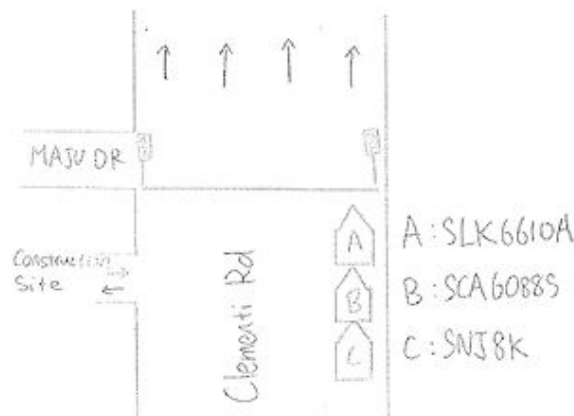

Describe Circumstances of the Accident

On 9 Dec 2022, at 1318 hrs, I was driving along Clementi Road in SNJBK in the first lane. There was a bend in the road and upon clearing the bend, it was visible that there were vehicles stopped at a traffic light. Upon seeing this, I immediately applied my brakes to slow down and stop the vehicle. However, as the road was wet, my vehicle skid and I was unable to brake in time, causing me to collide with the rear end of SCA6088S, and then he hit the vehicle in front of him, SLK6610A. Following the incident, we exited the vehicle, exchanged contacts and checked for injuries. The driver of SLK6610A was ok and proceeded to drive his vehicle off from the scene. Meanwhile, the driver of SCA6088S had decided to call a tow truck and also called his acquaintance to pick him up. While waiting, the female passenger that was seated in the front passenger seat of SCA6088S, who was then standing along the road divider together with me, said that she had sustained a bruise to her right hand. She then showed me what looked to be an approximately 2.5cm to 3.5cm bruise on her right hand in the area of the first metacarpal bone, proximal to the thumb. Throughout the duration, the male and female driver were both mobile and stood and walked in the area of the road divider. Their acquaintance arrived later on, followed by their tow truck and throughout the duration of waiting, I checked on both the male and female users of the vehicle. The male driver said that he was alright and shortly before the driver and passenger departed the scene in their acquaintance's van, the female passenger told me that she was alright and that she gets bruising easily due to blood thinning medication. Again, just before their departure, I checked and both driver and passenger said that they were alright before boarding the van and taking their leave.
