**Brief Details.**

On Thu 8 December 2022, at 11:05am, I was driving along lane 2 of PIE towards Changi Airport before the Eng Neo Avenue exit. The car in front suddenly braked and came to a complete stop. I also had to apply the brakes and also managed to come to a complete stop.

A few moments later, we felt an impact from behind. The car behind (SMW2339K) hit into my car causing it to move forward and hit the car in front (SKX2193G), with me in the car were the following persons:

- 1) my wife, Phuah Sock Pin, who was seated in front with me
- 2) my sister-in-law, Phuah Sock Tin, Doris who was seated behind my wife
- 3) my mom-in-law, Quek Pak Hoon, who was seated in the middle
- 4) my mom-in-law's domestic helper, Marites Anacan

**CONTINUATION OF REPORT**

The 3 passengers behind felt the impact from the car at the back. Doris, who is a pharmacist had her glasses thrown on the floor of the car as a result of the impact. Her head hit the back seat twice from the impact and for 5 minutes, she felt a sharp pain at the back of her head. It subsided but a dull pain persisted around her cervical spine area, which was tensed up. Her head was spinning, and she had to take paracetamol/ orphenadrine tablet 2 times that day. Her lumbar spine area also ached, and her uterus seemed to be moving back and forth 2 days after the accident. She had headache and her cervical spine area seemed tensed and hurt. She had to take paracetamol/ orphenadrine tab again to relieve the tension and pain.

My mom-in-law had bruises on her left arm, and also swelling below her eyes.

My wife felt tightness in her chest and also had a big bruise on the left side of her thigh just below the hip area. She went to see a doctor and was diagnosed to suffer from chest contusion, shoulder and backache as a result of the impact from the rear vehicle.

The helper had bruises on her right arm, felt dizzy and had a headache.

I wish to state that vehicle owner of SMW2339K did not slow down, and I felt that she was driving dangerously / recklessly as I noticed that the airbag was deployed. I wish to state that my vehicle was installed with in-car recording (front and back). I will need to check with my workshop personnel whether the recording was captured.
