

Describe Circumstance of the Accident

I was at beauty world area, driving by myself along Jalan Jurong Kechil going onto back to the East. I was exiting Jalan Jurong Kechil road, on the lane merging onto PIE (Changi) when the car in front of mine abruptly stopped, which led me to brake suddenly as well. While I managed to brake in time to avoid collision w/ the front vehicle, the van behind me (CRBK4889U) was unable to stop in time & collided into the rear end of my car. We subsequently moved to the road shoulder.
