8. **Consent under the Personal Data Protection Act (PDPA)**

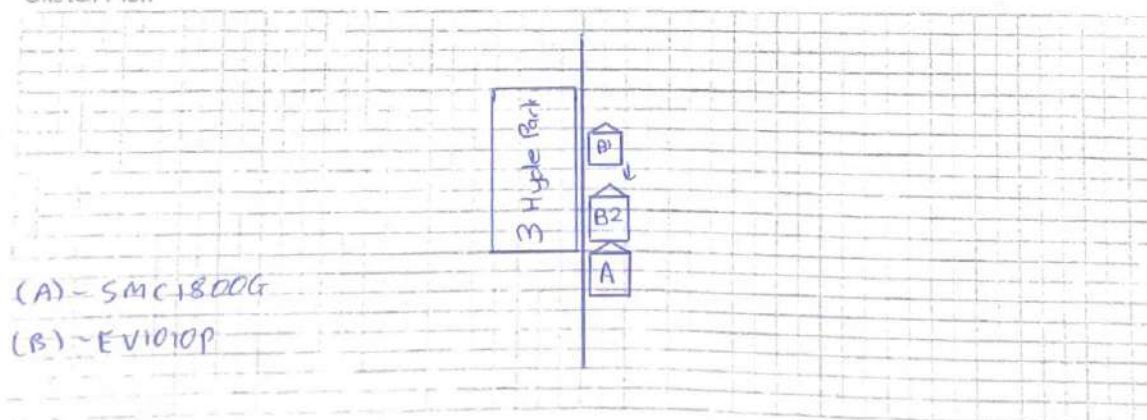
