





Brief Details.

Lane 1 and lane 2 was for turning right into AYE expressway and my vehicle SJT8422P was on 2nd lane and the other vehicle SJC184T was on 1st lane. As the traffic light turn green, i was going to make a right turn into AYE expressway, vehicle SJC184T on lane 1 did not turn right but speed up and went straight instead and hit onto the front right of my car (above front right wheel). The driver did not stop after hitting my car and proceeded her way straight. She does not have the intention to stop her vehicle so i gave her a couple long horn then she decided to stop her vehicle aside further down. She travelled on quite a high speed consider the traffic light just turned green and we are the first vehicle.

I drove towards her when she park her vehicle aside and i alighted to speak to her and took photo of my damaged car. I told her that the two lane we are in was strictly for turning right and came to my surprise she was actually shocked when i told her that. She was not the car owner as the vehicle belongs to her husband and she called her husband to enquire what she should do. During the accident, she have a passenger in her car and i have a passenger in my car which was my partner. No one was injured during this accident except my car front right was damaged by her vehicle.
