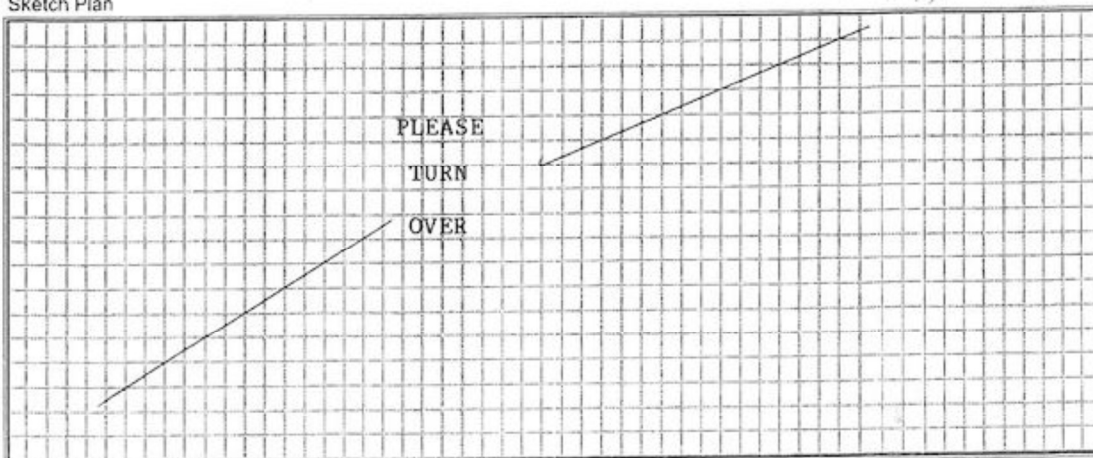

Sketch Plan



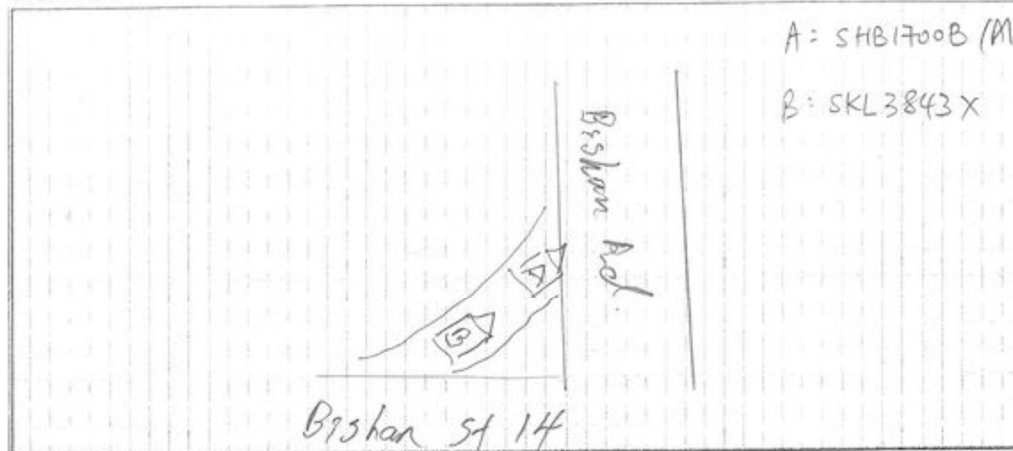
