Sir/Mdm,

I would like to request for a quotation for the mechanical inspection of a 46 seater bus (Registration plate: PA8968K) involved in a case of Negligence Causing Death.

2 The said bus was driven by the accused (bus driver) who was reversing into a narrow lot at the industrial building Carros Centre located at No 60 Jalan Lam Huat . Whilst he was reversing, the deceased was at the rear of the bus directing the driver to reverse. The bus driver then drove forward to adjust this position, where the deceased seems to have stuck between the side of the bus and a pillar. The deceased was then seen dropping on the floor and he was pronounced dead after being conveyed to hospital. Our investigation is still ongoing.

3 As we do not know the exact cause and circumstances which led to this incident, we would like to request for a full mechanical inspection of the bus for any possible issues which might have led to the accident. The bus had been seized and currently placed at the car park of Woodlands Police Division.
